# MCRC Rebukes LD29 Chair Lisa Everett's Comments on Her Censure



After receiving over 100 formal complaints from Republicans across Arizona, and condemnation from Republicans nationwide, the MCRC Executive Guidance Committee (EGC) acted on September 2, 2025, to censure LD29 Chair Lisa Everett.

In response to her public remarks following that censure, the MCRC has now issued a formal rebuke, reaffirming both the seriousness of her violations and the Party's commitment to Republican principles and platform integrity.



## **Key Points from the Rebuke**

- Dishonoring the Republican Platform Ms. Everett's actions aligned with radical leftist groups like Indivisible, protesting President Trump and Republican leaders, while using her LD29 Chair title to lend credibility.
- Immigration Policy Violations Her positions contradicted Republican commitments to secure the border, deport illegal aliens, and reverse open borders policies, as stated in Chapter Two of the Republican Party Platform.
- Weaponization of Courts ("Lawfare") By filing injunctions and legal complaints
  against fellow Republicans, she engaged in unethical lawfare contrary to Commitment
  One, Chapter Nine of the Party Platform, which pledges to stop weaponized
  government.
- Ethical Failures Every Republican officer swore an oath to discharge their duties faithfully and impartially. Ms. Everett's mistreatment and retaliation against PCs demonstrated behavior that is both unethical and unacceptable.

**Defaming Republicans** — After being censured, Ms. Everett escalated by calling MCRC leadership "radical extremists, racists, and hypocrites," further justifying the overwhelming censure vote.



#### The MCRC's Statement

"A Censure is a well-accepted, known, and frequently used practice of formal expression of strong disapproval or condemnation. We proudly stand by our decision to support our President's immigration policy, defend our members from leftist attacks and unjust lawfare. and hold our leadership accountable."



### 猝 Why This Matters

This rebuke underscores that Republican leadership is accountable to the Republican Platform. No Chair or officer may act in defiance of our Party's commitments, misuse their office, or disparage fellow Republicans without consequence.

The MCRC's decision to rebuke Ms. Everett's comments reaffirms its duty to:

- Defend President Trump's policies.
- Uphold the Republican Party Platform.
- Protect grassroots PCs and members from abuse of power and unethical conduct.

#### Action Requested

Demand that our LD Chair uphold Republican principles, the Republican Platform, and Integrity in all leadership actions – not leftist or anti-Republican behavior.

Demand that our LD Chair follow the MCRC EGC formal request to RESIGN so LD29 may elect leadership that upholds Republican Party Platform & Principles & Ethical Behavior (i.e., Spend your LD funds on her personal legal expenses).
