

MCRC EGC “CENSURES” LD29 Chair Lisa Everett



On September 2, 2025, the Maricopa County Republican Committee Executive Guidance Committee (MCRC EGC) voted, by an overwhelming margin of 23 to 6, to censure LD29 Chair Lisa Everett, a public rebuke that **embarrassed her personally and damaged the reputation of our Legislative District.** This action followed review of numerous complaints, supporting evidence, and Ms. Everett’s rebuttal.

A censure is one of the strongest disciplinary actions the Republican Party can take against one of its own leaders.

Key Findings

The MCRC EGC found that Ms. Everett:

1. **Partnered with the ultra-left West Valley Indivisible leader Brent Peak**, organizer of the “No Kings” and anti-Tesla protests, in support of keeping an illegal alien in the U.S. who defied a federal judge’s order.
2. **Publicly used her Republican LD29 Chair title on KTAR and other media platforms** in opposition to the Republican Party platform, drawing scrutiny and criticism upon the Party.
3. **Defied Trump administration immigration policy** that Americans voted for in overwhelming numbers.
4. **Weaponized the courts against her own PCs**— filed three injunctions and two criminal complaints, all denied, dismissed, or reviewed with no action taken (including cases against PCs Jugo, Skvara, & Shephard [outside LD29]).
5. **Used LD funds for her personal legal cases** and stated her intent to continue covering personal legal fees with district funds.

6. Directed the elected LD29 Treasurer to “make assumptions” on mandatory financial reports due to her withholding of receipts, risking false filings under penalty of perjury.

“Taken together, these findings represent serious violations of trust, governance, and Republican principles, underscoring why formal censure was both necessary and unavoidable.”

The Resolution

The MCRC EGC resolved that:

1. Lisa Everett is formally censured.
2. Restore all official communication channels to Treasurer & Board.
3. The **MCRC EGC formally requests her resignation so LD29** may elect leadership that upholds the Republican Party Platform and principles.

Why This Matters

A censure is one of the strongest disciplinary actions the Republican Party can take against one of its own leaders. It is not issued lightly. After months of complaints, testimony, and evidence, the **MCRC EGC determined that Ms. Everett’s conduct was so damaging to the Republican Party, to LD29, and to its elected PCs that a formal public rebuke (i.e., a Censure) was necessary.**

This action sends a clear message: **Our Party will not tolerate leaders who misuse their office, violate trust, or undermine the Republican Platform.** The censure ensures accountability and demands immediate corrective action so that LD29 can return to lawful, transparent, and principled operations.

Action Requested

Stay engaged. Share this resolution widely with fellow PCs.

Demand that our LD Chair uphold Republican principles, the Republican platform, and integrity in all leadership actions — not leftist or anti-Republican behavior

OR

Demand that our LD Chair follow the MCRC EGC formal request to RESIGN so LD29 may elect leadership that upholds Republican Party Platform & Principles & Ethical Behavior (i.e., Spend your LD funds on her personal legal expenses).
