

LD29 NEEDS A COURSE CORRECTION

Our Mission

To elect conservative Republicans — by raising funds for flyers, door hangers, Golden Tickets, and voter outreach. That mission requires **unity, transparency, and financial integrity**.

Why Change Is Needed

- **No Unity → No Donations:** personal attacks and division have driven away donors & volunteers.
 - **No Transparency → No Accountability:** officers denied access to all PC contact info.
 - **No Compliance → No Trust:** defiance of MCRC directives has **damaged LD29's reputation** and credibility.
 - **No LD Leadership that supports Republican Platform, Republican Principles, & Integrity**

LD29 Needs Leadership That Will:

1. **Restore transparency and lawful operations.**
 2. **Rebuild sufficient funds to support outreach, voter education, and campaign materials.**
 3. **Return meetings** to an accessible, professional venue.
 4. **Honor the Republican Platform and bylaws.**
 5. **Show Integrity by not using LD funds for "Personal" expenses**
 6. **Unite — not divide — our Precinct Committeemen.**

What's Happened Under Current Leadership

- **Censured & Rebuked:**
On **Sept 2, 2025**, the MCRC Executive Guidance Committee **censured LD29 Chair Lisa Everett** for **six serious violations** and **requested her resignation** (vote **23–6**). Violations included:

(1.) Partnering with Ultra-left activist Brent Peak to support illegal alien Kelly Yu from deportation.
(2.) Using LD29 Chair title in media appearances that bring criticism to the Party & Platform.
(3.) Defied Trump's Immigration Policies.
(4.) Weaponized the courts against 3 Republican PCs.
(5.) Using LD29 funds for "Personal" Legal expenses.
(6.) Not providing timely receipts to LD29 Treasurer & blocking communications.

A week later, the MCRC publicly **rebuked her post-censure comments** after she misrepresented the facts and attacked the Committee.
- **Non-Compliance:**
Lisa has **refused to comply** with the censure directives, continues to **block official communications**, and has **withheld the full PC roster** (providing only **13 of 170+**) under a **fabricated "privacy" rule** not found in our bylaws.

- **Financial Mismanagement:**
 - Chronic **late receipts**—often **3–6 weeks** after expenses—violating LD29 fiscal bylaws.
 - Told the Treasurer to “**make assumptions**” on Beacon filings and amend later.
 - **Gun Raffle proceeds delayed for 3 months**, then dismissed as unimportant because “the account isn’t interest-bearing.”
 - At one meeting, signed a receipt for **\$50** but handed **\$60**, then publicly mocked the correction.
 - Failed to notice when our **Constant Contact cost rose from \$38 to \$175** after increasing emails by 8,000 — showing poor financial oversight.
- **Misuse of LD Funds:**

Lisa **used LD funds** to pay for her **personal legal case materials** and told my attorney and me that the **LD would cover my \$6,000 legal fees**.

These actions were cited as **one of six official reasons** for her Censure.
- **Questionable Reporting Claims:**

Claimed to have **recruited 10 new PCs** through increased Constant Contact spending.

County records show **only four**, far fewer than claimed — and she has **never reconciled** the difference.

Financial Reality

- **Bank Balance Collapse:**

From **\$6,129 (Sept 30 2024)** to **\$1,370 (Sept 30 2025)** — a drop of nearly 80%.
- **We Can’t Afford Our Regular Venue:**

The usual Surprise meeting site (**\$250 per meeting**) is now unaffordable.

Instead, LD29 prepaid **\$500** for up to a year at a **smaller Sun City room** (≈50 seats, no tables).

Attendance has fallen to **9–15 PCs**, and fundraising has sharply declined.
- **Fundraising Failures:**
 - **5K Fun Run – Canceled**, net loss of **\$127**.
 - **Gun Raffle – Net + \$503**, but would have been a **loss** if LD had purchased the **\$700 gun**.

Lisa **won the raffle herself**, avoiding that expense —In reality, **another loss** for our LD.

LD29 deserves leadership with integrity, accountability, and a focus on winning Republican victories.
