

**GUIDELINES FOR THE
CLEVELAND SECTION ASCE
OUTSTANDING CIVIL ENGINEER OF THE YEAR AWARD**

1. The Cleveland Section's Outstanding Civil Engineer of the Year Award is a commendation to recognize the work of a Civil Engineer living within the boundaries of the Cleveland Section for his/her contributions to furthering the recognition of Civil Engineers through his/her work or prominence in the Community. The Recipient must be a member of ASCE, but not necessarily a member of the Cleveland Section.
2. A plaque is presented to the award recipient at the Annual Meeting. The Recipient and one guest are invited to attend the Annual Meeting at no cost.
3. The Award may be given annually at the discretion of the Board of Directors.
4. Nominees may be submitted to the Board of Directors by members of the Cleveland Section of ASCE or by non-members. Technical Committees are encouraged to submit nominations. Questions regarding membership status should be made to the Secretary prior to submission of the nomination.
5. All nominations shall be submitted to the Secretary who will certify that the nominee is a member of ASCE.
6. The Board of Directors selects recipient by majority vote or a quorum of its members by secret ballot.
7. The Recipient is normally the Cleveland Section's Nominee for the Cleveland Engineering Society's Engineer of the Year Award.
8. Nominations shall be in the form of a resume. The resume shall be limited to two pages. A short (one page) cover letter, signed by the Committee or person making the nomination, presenting the nominee and making the case for the nomination shall be submitted. Submission of nominations to the Secretary shall be made by March 1. After the nominee's membership status is verified by the Secretary, resumes and cover letters shall be submitted by the Secretary to the Board of Directors prior to the March Board of Director's meeting. Voting shall take place at said meeting. A Committee or nomination representative may present their nomination to the Board of Directors at the March meeting.
