OFFICIAL BUSINESS TO BE CONDUCTED AT THE SEPTEMBER 16TH MEETING

Because of government-mandated covid-related restrictions, NCPOA was unable to hold the election of new officers until now. However, members of the 2019-2020 Board of Directors have continued working on your behalf throughout this entire quarantine period. The long-delayed election will be held at the September 16th meeting. The Board of Directors is recommending the election of the following officers for 2021-22: **President: Larry Bowler, Vice-President: Tom Guichard, and Sergeant-at-Arms: Ed Doonan.**

In addition to this action, the Board of Directors is also asking for you to review our By-Law revisions. We have printed the changes and a copy of the entire new Bylaws document may be found on our website (<u>www.ncpoa.net</u>). Your Board will be available to discuss these changes and respond to your questions. The By-Law revisions will be voted upon at the September 16th Grass Valley meeting. Some Key revisions are highlighted below.

- + NCPOA was formed in the 1930's. The Northern California Peace Officers Association was not incorporated until 1978. Updates and revisions to the NCPOA By-Laws were last formally approved by vote of the membership in 2014. In the meantime, the Northern California Peace Officers Scholarship Fund (NCPOSF) was established to create a 501(c.3) tax deductible charity. Separate By-Laws were created.
- + This revision clearly establishes that NCPOSF is a subsidiary entity to NCPOA and that the new NCPOA By-Laws will also be the By-Laws of the NCPOSF.
- + Increases the size of the Board of Directors from six to ten. This adds the three (3) past Presidents and the Scholarship Manager.
- + Establishes that any member who has not paid dues for three (3) consecutive years may be removed from the membership roster.
- + Allows the Board of Directors to consider the appointment of qualified Associate members to the positions of Executive Director, Secretary, Treasurer, and Scholarship Manager.
- + Changed the fee for Life Time membership to \$500.00.
- + Recognizes electronic meetings of the Board of Directors (e.g., email, Zoom, etc.,) validates electronic/email voting.

MEMBERSHIP NOTIFICATION: At the June 2, 2021 NCPOA Board meeting it was decided that alcohol beverages will no longer be provided by NCPOA.at our meetings. We will supply an array of soft drinks, coffee and water. Some of the locations where we have luncheons, have Open Bars and may have beverages for sale. You may purchase on your own. It would be under their jurisdiction and responsibility.
