

Absolute Dance Center- also noted as ADC, will follow CDC guidelines in regard to operating a business during the Covid-19 pandemic.

As a parent or guardian, I do hereby forever release, waive, discharge, and covenant not to hold Absolute Dance Center responsible for contracting or the transmission of the Covid-19 virus, or any other illness that can be communicably spread by my or my child's participation in classes provided by Absolute Dance Center.

I understand that while ADC has undertaken reasonable steps to lessen the risk of transmission of COVID-19 in connection with the Services provided, ADC is not responsible in any manner for any risks related to COVID-19 in connection with the Services. I understand that the World Health Organization has classified the COVID-19 outbreak as a pandemic. I further understand that COVID-19 is a highly contagious and dangerous disease, and that contact with the virus that causes COVID-19 may result in significant personal injury or death.

I am fully aware that participation in the Services offered by ADC, carries with it certain inherent risks related to COVID-19 transmission ("Inherent Risks") that cannot be eliminated regardless of the care taken to avoid such risks. Inherent Risks may include, but are not limited to, (1) the risk of coming into close contact with individuals or objects that may be carrying COVID-19; (2) the risk of transmitting or contracting COVID-19, directly or indirectly, to or from other individuals; and (3) injuries and complications ranging in severity from minor to catastrophic, including death, resulting directly or indirectly from COVID-19 or the treatment thereof. Further, I understand that the risks of COVID-19 are not fully understood, and that contact with, or transmission of, COVID-19 may result in risks including but not limited to loss, personal injury, sickness, death, damage, and expense, the exact nature of which are not currently ascertainable, and all of which are to be considered Inherent Risks.

Absences: Please call or email in all absences. I understand that if my child will be absent due to illness, or family vacation. Refunds, Credits, or Tuition holds for missed classes will not be made, unless the child is on an extended medical excuse by a doctor. A Dr. note is required with date of return to class.

•Damages: I understand that the studio is not responsible for the loss or destruction of personal property. I understand that I am responsible for any damages my children (student and non-students) may cause while on the studio premises.

•Photo Release: I agree to allow my child's photo to be used for promotional material for Absolute Dance Center.

Absolute Dance Center reserves the right to require any registered individual/family to notify Absolute Dance Center, its owner, or office manager, of the withdrawal of attendance, 7 days (one week) prior to the 1st of the upcoming month. Failure to properly notify the dance center of withdrawal under the term agreed upon will result in a scheduled tuition charge on the 1st of the month. Any and All Tuition payments pre-paid will not be refunded.

I understand that dance is a physical activity, and as a parent or guardian, I will be contacted in the event of a medical emergency if I am not present in the dance studio. The owner of Absolute Dance Center or an appointed representative will sign for care only if I cannot be reached. I hereby authorize medical care only if I cannot be reached and I authorize medical care under only those circumstances. I agree that I will not hold Absolute Dance Center, its owner, faculty, or employee liable for injuries or illnesses contracted by my child while a student of Absolute Dance Center.

•Registration/Tuition: I understand that all Registration and tuition payments are non-refundable.
