Dear Mr. Fox:

Thank you for the letter requesting approval of a pool/spa operator course. Our Office approves the Aquatic Training & Consulting Service's Certified Pool/Spa Course, as satisfying the requirements of Maryland's Public Swimming Pools and Spas Regulations, COMAR 10.17.01.42.

A person 16 years old or older who completes the course with a minimum grade of 70 percent on the written examination may receive a 3-year pool/spa operators' card from a local health department, as specified in Maryland's Public Swimming Pools and Spas Regulations, COMAR 10.17.01.41. Also, local jurisdictions including Anne Arundel, Baltimore, Montgomery, Howard and Prince George's Counties and Baltimore City have adopted local swimming pool and spa codes and may require additional testing before a certified pool and spa operators' card will be issued. Please inform all students that local requirements may apply.

Please note that pool and spa operators' courses may be subject to an on-site audit by one of our staff or staff of a local health department. Maryland's Public Swimming Pools and Spas Regulations, COMAR 10.17.01.41 also provides that this Office or a local health department may summarily suspend a pool or spa operators' certification if the operator does not comply with applicable regulations and procedures at a public pool or spa in Maryland.

It is requested that you notify this Office in advance concerning the scheduling of all pool and spa operators' courses by Aquatic Training & Consulting Service. Enclosed is the Maryland's Public Swimming Pools and Spas Regulations, COMAR 10.17.01. Please provide this information to all students taking the pool/spa operator course.

RE: Application to be recognized as a provider and proctor for Pool Operator training within the City of Alexandria

Dear Mr. Rob Fox:

This letter is to confirm that your organization (Aquatic Training and Consulting Services) has been approved to provide and proctor Pool Operator training within the City of Alexandria. Approval is subject to the following conditions:

- 1. The approval will be reviewed annually, and may be revoked if found to be in breach of any of the conditions below, or it is determined that exams are not being administered in a fair and ethical manner.
- 2. Changes to the course content or structure must be communicated to the Health Department in writing, at least 10 days prior to any changes being made. If the Director (or designee) determines that the changes would invalidate the approval, you will be notified in writing to that effect.
- 3. The course must cover the items specified within the Model Aquatic Health Code, with the exception of:
 - conversion of units between English and metric
 - swimming pool renovation & facility design
 - facility winterizing
 - mechanical room ventilation equipment (HVAC)
 - total dynamic head (pump hydraulics) head and friction loss and calculations.
- 4. Your classes may be independently audited by a member of the Environmental Health team with a view to ensuring that it continues to maintain the standards and cover course content as agreed.
- 5. Contact details and credentials for all trainers and proctors will be provided to the Health Department. If trainers change during the season, the Health Department will be notified


