Mr. Reidy came to give us an update from Wagonbrenner - He brought a big graphic of an Ariel view

1st Phase will be 62 acres 2nd Phase will be 118 acres

Right now they are clearing and grading and it will go on thru the summer. They will be using the MKSK landscape architects, which is the same landscapers that work with the Metro Parks. This is an area that was previously used as a "solid waste" landfill and is now being redeveloped for residential. June of 74 was the last date of processing solid waste. Trash was dumped there. There will be methane gas controls as a precaution.

Questions:

Where will the Main Entrance for this development be?

On Trabue, right were the entrance of the sight of the Minutemen Helicopter Co.

Will the River embankment be preserved?

Yes, with plenty of additional space and setbacks to preserve other natural barriers.

Will you be using native plant materials? Yes, same as the Metro Parks

What about the traffic?

There will be a traffic study (maybe in the next 60 -90 days) Wagonbrenner hires the traffic engineers and they will have to sign off on the plans.

Will sidewalks be put on Old Dublin Road? All building will be done up to the proper code

Do you anticipate high density in this area?

At this time we are planing 234 Single Family Homes 780 Apartment Units, possibly some 4 story buildings - price point \$1100 - 2000 20,000 sq. ft. office space to be developed in 5- 10 years Wagonbrenner will not be doing spec homes

When do the Park structure open?

The infrastructure will be completed by 2020, Metro Parks will be open 2018 and the amenities to open 2019 and 2020. This will a Rustic style and less programmed. Most likely there will be a community center in this area. In June, the fence goes up to buffer the existing quarry property.

Wagonbrenner desires to have a good working relationship with this Area Commission, just as they do with other communities that they have constructed - Harrison West and Italian Village.

There is also another group of apartments that is coming to this area, called Quarry Lofts. It is under construction now - Preferred Living is about 6 mos. to a year ahead of the Wagonbrenner Projects.
