This group came to bring information to us regarding the new Jail facility being built on Fisher Road that will replace the old and outdated facility downtown Columbus. They will be starting the site work in October of 2017 with hopes of finishing the project sometime in 2019. They are wanting to hire Local - at least 50% of the workforce for this project from Franklin County. They are directing people to the County website to make vendor application regarding bidding on jobs for this project. This is not at prison, but a jail, where people are still presumed innocent. 73% are recycled back out into society.

### **Ouestions:**

<u>Security Levels?</u> This will be a Direct Supervision Facility with Low and Minimum-Security levels. Maximum of 64 people per pod.

<u>How many prisoners?</u> 1st phase will hold 872, 2nd phase up to 2,200 capacity. Currently the downtown facility holds 643 and the Jackson Pike facility holds the 1600.

<u>Discharge process?</u> Currently working on a plan with COTA. Minimum road changes during Phase 1 of the project.

<u>Video arraignments?</u> The goal is for each pod to have its own video facilities for arraignments, meetings with council and other types of visitation.

<u>Smoke free?</u> Yes, this will be a smoke-free facility like all the other city and county facilities.
