#### Zoning Committee Report - Jessica Dyszel

There was application up for a vote. The 5.5 acres next to Johnny's Tavern on the North side of Trabue Road.

The text in the application requests a max height of 60 feet and a density of 35,000 sq ft/acre. The zoning committee discussed a number of concerns including scale and density and the traffic impact. Rob proposed some modifications to the application.

- 1). Limit the height of the building to 35 feet and density to 20,000 sq ft/acre
- 2). Cell towers prohibited
- 3). Preferred would have to complete anything requested by the City Staff

Mr Jared Smith, from Preferred Living, brought more pictures/maps and tried to explain that the currant occupants want to know why their property is being devalued by this proposal because it changes the zoning of this phase, compared to the other phases of this property development.
