The LWVA Charter Review Task Force is continuing its review of the Amherst Home Rule Charter in relation to League good government principles. The Task Force will be hosting a series of public Zoom discussions on questions related to potential Charter amendments. Save the dates and spread the word.

The public is cordially invited to participate or just listen in to the public discussion. The first part of the discussion will be the presentation of potential amendments to the Charter, how they may relate to good government principles, and how five years of experience has demonstrated whether an amendment is or is not needed. We will then open to public comments.

The LWVA'S "Good Government" Principles

- 1. Widespread and inclusive participation
- 2. Diversity in the community reflected in government
- 3. Openness and full disclosure
- 4. Checks and balances of power among the executive, legislative and administrative branches of government and the electorate
- 5. Honesty and non-corruptibility in all decision-making
- 6. Efficiency, based on professional management and timely decision making
- 7. Accountability for political and fiscal decisions

Voters Service News

This month, Voters Service volunteers tabled at the <u>Collective Power for</u> <u>Reproductive Justice</u> conference at Hampshire College. Many thanks to Sue Lowry, Sandi Albertson-Shea, and Adele Gladstone-Gilbert for representing our League, and for registering and informing voters! The conference's theme this year explored "ways of organizing, connecting, and cultivating practices that center impacted communities, foster collective resistance, and practice community care." We are happy to have been able to have a League presence and get people thinking about the power of their vote!

The LWVMA Voters Service Committee met this month to discuss the success of our partnership with the Disability Law Center (DLC) and Rev Up to survey polling places for accessibility. They were blown away by the thoroughness and reach of the League's volunteers. So, thank you again to all who participated—we made a big impact and helped them move towards a more comprehensive study. Of course, if the Votes Act goes through intact, monitoring and ensuring ADA compliance at polling sites would ideally be the job of the Secretary of State.

We also discussed upcoming work on developing questions for state candidates for the upcoming primary and general elections. We will create a subcommittee for that job. A representative from Third Act came to let us know of their work trying to connect with community colleges to register voters. If any of our members have any connections to the community colleges in our area, please let <u>Jessica Ryan</u> know so that she can connect you to their efforts.

Health Care

The Health Care Committee is getting ready for Convention on June 28–30, planning for two caucuses and some tabling. ("Caucus" in this League usage is a meeting organized by local or state Leagues to promote a cause or course of action.) We applied for in-person caucuses, but also plan to show them on Zoom.

The two topics accepted are:

- 1. Vote for the Vermont Update to the US Privatization Position (in conjunction with LWVVT); and
- 2. Moving Hearts, Changing Minds: Using Storytelling for Advocacy, (partnering with the Port Washington-Manhasset League [NY]).

The second caucus was designed in part to help improve the first one. That is, we should be able to make the Vermont update more convincing by incorporating brief stories that follow a few basic principles to make them memorable and moving.

Connecticut River News

Connecticut River Relicensing Update

The Northampton League, the Franklin County League, and the Berkshire County League have joined the Amherst League in submitting a statement to the Federal Energy Regulatory Commission (FERC) pertaining to the relicensing of the Turner's Falls Dam and the Northfield Mountain pumped storage facility.

We submitted our statement for FERC to the national League of Women Voters. This submission is required by the national League when we are proposing to take action on a national issue, e.g., the relicensing of a dam and water storage facility. We have not yet received a response from the national League to our request for permission to file our statement with FERC.

The good news is that we have received emails from Senator Jo Comerford and from the Connecticut River Conservancy informing us that FERC has extended the deadline for filing these relicensing statements from next Monday, April 22, to Wednesday, May 22. Thus, we have more time to hear back from LWVUS.
