Ordinance No. 64 2020

ORDINANCE AMENDING ORDINANCE NO. 40-2020, TO CORRECT TWO NUMERALS REFERRING TO THE FUND NUMBERS OF APPROPRIATIONS FOR THE YEAR 2020, AND DECLARING AN EMERGENCY

WHEREAS, two of the Fund numbers contained in Exhibit A of Ordinance 40-2020, which was passed by the Council on July 14, 2020, are incorrect and should be corrected as soon as practicable; and

WHEREAS, although two of the Fund numbers referred to in Exhibit A of Ordinance 40-2020, are incorrect, the names and dollar amounts of the two funds to which they apply, Capital Projects Fund II and Norwood Corona Virus Relief Fund, are correct; now therefore,

BE IT ORDAINED by the Council of the City of Norwood, State of Ohio, that:


SECTION 1. That the two Fund numbers referred to in the attached Exhibit A, are correctly stated in the attached Exhibit "A" as follows:

SECTION 2. This Ordinance, amending Ordinance No. 40-2020 only corrects the numeral references to Exhibit A of Ordinance 40-2020, and so has no financial impact upon the Third Amendment of the Financial Recovery plan by the Financial Planning and Supervision Commission on or about March 31, 2020, which plan includes these appropriations.


SECTION 3. This ordinance is hereby declared an emergency ordinance and a measure necessary for the immediate preservation of the public peace, health, safety, and general welfare and shall go into effect forthwith. The reason for said emergency is to correctly refer to two of increases in the permanent appropriations of the two Funds.


