Ordinance No. 34 20 18

**ORDINANCE AMENDING ORDINANCE NO. 33-2009 TO ADD "CLERKS (PERMANENT PART-TIME)", AND DECLARING AN EMERGENCY**

**WHEREAS**, Council for the City of Norwood recognizes that the City is in a state of fiscal crisis and has been declared to be in a state of "fiscal emergency" by the State of Ohio; and

**WHEREAS**, the Treasurer also recognizes the City's fiscal situation and is able to retain a part-time Clerk rather than a full-time employee with the City of Norwood; and

**WHEREAS**, in 2009, Council amended Ordinances No. 73-1999 and 7-2007 to update the salary ranges and listing of non-union, unclassified positions within the City of Norwood; and

**WHEREAS**, Ordinance 73-1999 included "Clerks (permanent part-time not to exceed 29 hours per week)", which position was not included in Ordinance No. 33-2009; now therefore,

**BE IT ORDAINED** by the Council of the City of Norwood that:

**SECTION 1.** Effective January 1, 2019, Section 1 of Ordinance No. 33-2009 is amended to include the following non-union, unclassified position within the City of Norwood:

Clerk (permanent part-time, not to exceed 29 hours per week) ..... \$13.50/hr – \$18.00/hr

**SECTION 2.** This ordinance is hereby declared to be an emergency ordinance and a measure necessary for the immediate preservation of the public peace, health, safety, and general welfare and shall go into effect forthwith. The reason for said emergency is the necessity to provide for the continued functioning of the Treasurer's Office without a disruption of service.
