

## Ordinance No. 48 20 20

## ORDINANCE INCREASING METERED AUTOMOBILE PARKING RATES TO \$1.00 PER HOUR, AND DECLARING AN EMERGENCY

WHEREAS, Ohio Revised Code §737.022(C) authorizes the Council to establish and maintain reasonable fees and charges for the privilege of motor vehicle parking at various metered spaces within the City of Norwood; and

WHEREAS, currently the City of Norwood charges twenty-five cents (\$0.25) per hour for a motor vehicle to park at a metered parking space within the City of Norwood, and that parking rate has not been increased for many years, despite the fact that the costs of parking meter purchases, maintenance and collection have increased during those years, and that the metered parking rates for the neighborhoods within the City of Cincinnati that adjoin the City of Norwood range between \$0.75 and \$1.25 per hour; now, therefore,

BE IT ORDAINED by the Council of the City of Norwood, State of Ohio, that:

**SECTION 1**. That the motor vehicle parking rates at the parking meters within the City of Norwood are increased to \$1.00 per hour, and the Director of Public Safety-Service is authorized to implement this rate increase.

**SECTION 2**. This ordinance is hereby declared an emergency ordinance and a measure necessary for the immediate preservation of the public peace, health, safety, and general welfare and shall go into effect forthwith. The reason for said emergency is the need to act promptly to attempt to take advantage of the opportunity to acquire approximately 110 new meters, which only makes economic sense if the parking meter rates are increased.
