Ordinance No. 10 2020

ORDINANCE AUTHORIZING THE MAYOR AND SAFETY-SERVICE DIRECTOR TO ENTER INTO A COLLECTIVE BARGAINING AGREEMENT WITH LOCAL #3278 AND OHIO COUNCIL 8 OF THE AMERICAN FEDERATION OF STATE, COUNTY, AND MUNICIPAL EMPLOYEES (AFSCME), AFL-CIO, CONSISTENT WITH THE TERMS OF THE ATTACHED EXHIBIT A, FOR THE PERIOD FROM JANUARY 1, 2020 THROUGH DECEMBER 31, 2021, AND DECLARING AN EMERGENCY.

WHEREAS, the City and Local #3278 and Ohio Council 8 of the American Federation of State, County and Municipal Employees (AFSCME), AFL-CIO, have negotiated a Collective Bargaining Agreement for the Contract Period from January 1, 2020 through December 31, 2021, which has resulted in a tentative agreement; now, therefore,

BE IT ORDAINED by the Council of the City of Norwood, State of Ohio, that:

SECTION 1. The Mayor and Safety-Service Director are hereby authorized to enter into a Collective Bargaining Agreement with Local #3278 and Ohio Council 8 of the American Federation of State, County and Municipal Employees, AFL-CIO for the Contract period from January 1, 2020 through December 31, 2021, in accordance with the terms set out in the attached Exhibit A, made a part hereof by reference.



This ordinance is hereby declared to be an emergency ordinance and a measure necessary for the immediate preservation of the public peace, health, safety and general welfare and shall go into effect forthwith. The reason for said emergency is the necessity to proceed forthwith in order to prepare a new Financial Recovery Plan this month, as required by the fiscal emergency provisions of Ohio law.


