## RESOLUTION AFFIRMING THAT FUNDS FROM THE HAMILTON COUNTY CORONAVIRUS RELIEF DISTRIBUTION FUND MAY BE EXPENDED ONLY TO COVER THE COSTS OF THE CITY CONSISTENT WITH THE REQUIREMENTS OF SECTION 5001 OF THE CARES ACT AS DESCRIBED IN 42 U.S.C. 601(d) AND ANY APPLICABLE REGULATIONS

CARES Act) was signed into law by the President of the United States on March 27, 2020; and WHEREAS, the Coronavirus Aid, Relief, and Economic Security Act, 116 Public Law 136, (the

- (3) Were incurred during the period that begins on March 1, 2020, and ends on December

Norwood, Ohio, that the City Auditor and City Treasurer take all necessary action to: FURTHERMORE, in compliance with H.B. 481, be it resolved by the Council of the City of

- (1) On or before October 15, 2020, pay any unencumbered balance of money in the City of Norwood's local coronavirus relief fund to the County Treasurer;
- (2) On or before December 28, 2020, pay the balance of any money in the City of by the Director of the Ohio Office of Budget and Management; and Norwood local coronavirus relief fund to the state treasury in the manner prescribed
- (3) Provide any information related to any payments received under H.B. 481 to the Director of the Ohio Office of Budget and Management as requested.
