Ordinance No. 2 20 20

**ORDINANCE AUTHORIZING THE SAFETY-SERVICE DIRECTOR TO ENTER INTO A CONTRACT WITH MEDICOUNT MANAGEMENT, INC. FOR THE CONTINUATION OF EMS BILLING SERVICES FOR THE NORWOOD FIRE DEPARTMENT, AND DECLARING AN EMERGENCY.**

**WHEREAS**, Council adopted Ordinance 26-2004, Ordinance 36-2009, Ordinance 52-2011, and Ordinance 37-2015 authorizing the Safety-Service Director to enter into a contract with Medicount Management, Inc. for EMS billing services for the Norwood Fire Department; and,

**WHEREAS**, Council desires to continue to retain Medicount Management, Inc. as a provider of EMS billing services; and,

**WHEREAS**, Council finds that the professional services provided by Medicount Management Inc. in providing EMS billing services are exempt from competitive bidding; now therefore,

**BE IT ORDAINED** by the Council of the City of Norwood, State of Ohio, that:

**SECTION 1.** The Safety-Service Director is hereby authorized to enter into a contract with Medicount Management, Inc. to provide EMS Billing Services for the Norwood Fire Department in accordance with the terms of the contract, attached hereto and incorporated by reference herein as Exhibit "A".

**SECTION 2.** The City Auditor is hereby authorized to draw and the City Treasurer to pay warrants for the foregoing purpose out of the **GENERAL FUND**.

**SECTION 3.** This ordinance is hereby declared to be an emergency ordinance and measure necessary for the immediate preservation of the public peace, health, safety, and general welfare and shall go into effect forthwith. The reason for said emergency is that it is necessary to retain adequate EMS Billing Services for the City of Norwood Fire Department and to prevent delayed revenues from being forwarded to the City.




