Ordinance No. 5 2020

**ORDINANCE AUTHORIZING THE DIRECTOR OF SAFETY-SERVICE TO ENTER INTO A REVISED 60 MONTH CONTRACT, UNDER THE STATE BID PURCHASE PROGRAM, WITH CINCINNATI BELL TELEPHONE, LLC FOR CERTAIN TELEPHONE AND INTERNET SERVICES, REPLACING THE CURRENT 60 MONTH CONTRACT PASSED BY ORDINANCE 5-2019 AND AMENDED BY ORDINANCE 38-2019, AND DECLARING AN EMERGENCY**

**WHEREAS**, the current contract for certain telephone and internet services between the City of Norwood and Cincinnati Bell Telephone Company, LLC needed to be revised; and

**WHEREAS**, the revised contract will include some upgrades to the current fiber circuits, requiring additional charges of \$263.50 monthly; now therefore,

**BE IT ORDAINED** by the Council of the City of Norwood, State of Ohio, that:

**SECTION 1.** That the Director of Public Safety-Service is hereby authorized to enter into a revised 60 month contract, under the State Bid Purchase Program, in accordance with specifications on file in the office of the Director of Public Safety-Service, for additional telephone and fiber internet services.

**SECTION 2.** That the City Auditor is hereby authorized to draw and the City Treasurer authorized to pay warrants in an amount and according to the schedule, outlined in the attached "Exhibit A", for the purchase of the upgraded telephone and internet services.



The reason for said emergency is the necessity to proceed forthwith, to replace the current contract and the time needed for scheduling stated upgrades.


