The Session of First Presbyterian Church met in the Library at 6:00 pm on Thursday, Sept. 14, 2023 for its stated meeting. Rev. Darryl Baker called the meeting to order and opened with prayer. A quorum was present.

<u>Agenda:</u> Charlie Leveridge made a **Motion** to approve the amended agenda. Zack Vaught seconded, and the **Motion** carried.
