IV. Treasurer Report - Total assets: \$796,383

Grant disbursements:

• Nothing notable last month FY23-24 YTD grant disbursements: \$365,974

Notable since last meeting:

- \$93,512 revenue from Spring Gala (excluding corporate sponsorships); \$62,777 net profit
- \$1,750 for 8th grade graduation party deposit
- \$1,750 for additional Glow Party expenses
- \$1,460 for winter referee fees

V. Leadership Report

- Reconsider the Sweetest Day & Valentine's Day fundraisers brainstorm new fundraising ideas
- Budget update different approach from CPS; previously student-based budgeting (e.g., X dollars per student); now calculating number of teacher positions and discretionary

programming, then multiplying by an "opportunity index" and allocating funding; our opportunity is high so our funding will be compressed in the formula

- Art & Music programs will be covered by new budget formula, but other funding gaps will emerge need to reevaluate FOA fundraising approach and messaging
- Covid-19 relief funding has expired
