

**ARTICLES OF INCORPORATION OF
CENTRAL NEBRASKA SENIOR GOLF ASSOCIATION**

The undersigned, Incorporator and Directors of Central Nebraska Senior Golf Association, pursuant to the Nebraska Nonprofit Corporation Act, adopt the following articles of incorporation for such Corporation:

ARTICLE I: The name of the Corporation shall be: Central Nebraska Senior Golf Association.

ARTICLE II: The period of duration of the Corporation is perpetual beginning with and following the filing of the original Articles of Incorporation in the office of the Nebraska Secretary of State.

ARTICLE III: The Corporation shall have one class of members.

ARTICLE IV: This Corporation is a mutual benefit corporation. Said Corporation is organized exclusively for fostering amateur sports competition, specifically amateur golf purposes, including, for such purposes, providing Scholarships to high school students who have excelled as high school students and a member of their respective golf team.

ARTICLE V: The Corporation reserves the right to amend or repeal any provisions contained in these Articles of Incorporation in the manner now and hereafter permitted by law, and all rights conferred upon members herein are granted subject to this reservation.
