REVIEW YOUR QUALIFICATIONS & FINANCES

ELIGIBILITY

- Be 18+ years of age
- Yourself & household members are in good mental & physical health
- Pass a background check

HOME

- Someone must live in the home
- Sufficient space, lighting, and ventilation is needed
- Two remote exits for safe evacuation
- Permission of landlord (if renting)
- Near water? Fencing, barriers, or alarms may be necessary

START UP FUNDS

- Background checks
- Training
- Health exam & TB test
- Equipment

TRAINING

- NYS Health & Safety Competencies
- CPR & First Aid certification
- Pior experience or combination with education/ training
- Access to the outdoors
- Smoke detectors, carbon monoxide detector, gates and other safety measures
- Developmentally appropriate toys and materials for children

THE 90-DAY PROCESS

Once you have reviewed your qualifications, finances, and home environment, you can obtain the official application by completing the New York State Office of Children and Family Services Online Orientation Session or attend one of our monthly orientation sessions.



DURING MONTH ONE

- Complete the training for CPR/First Aid certification
- Complete & submit the NYS Application with the CPR/First Aid certificate
- Get fingerprinted and submit background check materials
- Schedule an appointment with your Registrar or Licensor for a home visit
- Register for Health & Safety for Becoming a Family/Group Family Provider



DURING MONTH TWO

- A Fire Safety representative will call and schedule an inspection with you
- Complete and submit any remaining NYS Application pages



DURING MONTH THREE

- Correct any issues identified by the Fire Safety representative
- Schedule your final Fire Safety inspection
- Call your Registrar or Licensor to complete your NYS Application for approval
