### THEY'RE BACK!



Fifty-five third graders from Belveder Elementary School attended the first post-Covid -19 "simple machines" program at the Mill on Tuesday, April 12. Another 50 were scheduled for April 13. We are sooooo happy for this popular program to be back in business!

Julie Gurnee, site manager, reports that they currently have 16 schools scheduled for attendance this spring with a total of 46 classes and 1018 students.

She also reports that there will be weekly scout programs running through the spring; nine summer camps are schedule for the summer, and additional mill tours and tour dates are scheduled for the spring and summer.

She is also working on building partnerships with Great Falls Friends and Neighbors, the Residence at Colvin Run, and looking to foster more partnerships in the community.

### AN ALLIANCE OF FRIENDS

"Friends" of a number of county parks are collaborating to petition the BOS to increase funding for Fairfax County parks. This initiative would permit, among other things, the filling of vacant approved county positions and the hiring of sufficient staff to fully operate county parks.

Thirty years ago the park system was allocated about 1 percent of the annual county budget. Today that percentage has been reduced to about .06 percent. While bond issues have been approved to cover capital improvements, operating budgets, which fund personnel needs, have not kept up. As consequence, operations of the parks has been significantly constrained. In the case of Colvin Run Mill, we have been reduced from five full time, two part time, and two seasonal employees to only two full time, two part time, and two (?) seasonal employees. Other park sites are in a similar situation. Hence the desire to highlight to the Board of Supervisors (BOS) the need for additional funding throughout the park system.

Traditionally, Friends groups from a number of sites have advocated for their sites at the annual budget hearings in front of the BOS in April. This year, as a result of this alliance, speakers included statements about the general problem throughout the Fairfax County Park Authority. The goal is to engender community support which can be translated into expressions of support for the park system and help persuade the BOS to re-examine the funding priorities.

Through a series of weekly virtual meetings, the alliance members, usually about fourteen participants, channel the organization and marketing

## SUPPORT ADDITIONAL FUNDING FOR FAIRFAX COUNTY PARKS

### PRESIDENT'S MESSAGE

People and plants are popping up all around the park, a sure sign of spring. The miller is milling, the smith is smithing, the carvers are carving, ducks are paddling in the pond, and two rooms in the miller's house are now open to the public, yet another good reason to hang out at Colvin Run.

Properly maintaining the mill and site requires resources that the Fairfax County Park Authority has fallen short of, being a low priority in the county's overall budget. Gene's excellent article on a new Alliance of Park Friends is just one of several initiatives to advocate for more resources for the parks. I was honored to present testimony to the Board of Supervisors and was moved by the stories of others about how their parks have suffered from neglect or shortage of staff.

As Friends we want to help all we can, but we cannot and should not become an extra bank account or a source of free help to substitute for what properly should be regular operations and maintenance expenditures. This advocacy will be a long haul. We need your help to convince the Board of Supervisors to give a higher priority to parks in the budget, and, in the meantime, we need your help as volunteers.

Everyone enjoys a "small world" story. Here is my latest. I was celebrating Nowruz, the New Year which is the first day of spring, with some Afghan families. After the symbols of the traditional foods were explained, we lined up to partake in the feast. I struck up a conversation with the man next to me. He said he was an engineer – a real one (many Afghan men call themselves engineers) – who had worked on a project with the Army Corps of Engineers in Afghanistan. His performance landed him a job with a highway construction firm in Northern Virginia. "Where have you been working?" "On Route 66 and Route 7." Curious, I explained that I had been at Colvin Run Mill gardening the previous Friday. I had noticed progress on the tunnel being constructed under Route 7 with men in yellow safety jackets scurrying around. He looked at me with surprise: "I was there that day testing the strength and thickness of the concrete for the tunnel." Small world.

### TUNNEL CONSTRUCTION CONTINUES

#### **ROUTE 7 WIDENING**

Route 7 construction is moving apace and is really impacting the stretch that passes by the mill site. It may delay accessibility for some time to come.

The north half of the tunnel is now being built (see photo) and has necessitated a major temporary lane change in Route 7. We are working with Supervisors John Foust (Dranesville) and Walter Alcorn (Hunter Mill) in whose jurisdiction the potential trail connections reside to persuade the county to



make the necessary trail connections that will permit the full usefulness of this grand tunnel and provide routine access to the mill site property on the south side of Route 7.

## **MILLER'S HOUSE DEDICATION**

Ceremonies took place on Sunday, April 3, 2022, to officially cut the ribbon and open the doors of the historic Miller's House at Colvin Run Mill in Great Falls, Virginia. Officials, descendants of past millers who had occupied the historic house, Park Authority staff and guests attended the brief ceremony, followed by tours of the house.

After extensive renovation, the house now offers an interactive design representing home life in the early and late 1800s. The two lower rooms of the house have been designed for guests to immerse themselves in the past. Sit at the writing desk, play a game from 1810 or try out an 1890s toy. The multi-year project was completed in 2020, but due to COVID-19 the opening was de-laved.

## COLVIN RUN MILL CARVING CLASSES A SUCCESS

When Covid-19 disrupted the Northern Virginia Carvers (NVC) ability to meet, our safest place to meet

was outside the barn at Colvin Run Mill. As restrictions changed we were able to move inside. Thank goodness for that, especially when the weather turned rainy and cold.

In order to expand our community presence, Fairfax County Parktakes was the answer. Parktakes is Fairfax County Parks and Recreation offerings of so many activities and classes throughout the county. We developed a three class session for the New Year of 2022. There was an eight student



(sixteen years old and older) capacity for the package of classes.

Seven students signed up! Yahoo! With the combined efforts of NVC volunteers (Todd Andre-Colton, Jack Edwards, Michael Wine and Joyce Spieler) we developed the program for the sessions. Since, this was a beginners' class the age old, tried and true carving a ball on a stick provided a fantastic first learning project. I thought of a little twist to this project. We carved a snowman ornament. Three round forms... a great practice in carving in the round.

The otter letter opener was introduced next. The choice of projects included were purposed for a useful end result. The students embraced carving skills with vigor. Of course, carving safety guidelines were shared and followed by all. Carving and Covid inclusive. The second class, the students carved the push/pull oven rack squirrel. This provided more carving skills as to forming curves, concave and convex. The squirrel added the bonus of a kitchen helper in the making.

During our classes the volunteers brought many different carving tools, supplies and carved examples for the students to see, feel and use for more carving exposure.

The sky was the limit. We did have a guest carver come visit. Phuong-Anh Nguyen, a wonderful carver, who produces realistic historical oriental carvings. She recently had a book published of her gorgeous carvings. It was a pleasure to have her as a guest at the Mill.

To round out our session, the last project was a stylized Santa. This project was a challenge because the students started with a rectangular piece of wood and the ability to proportion the final carving to their own vision. Michael Wine headed this project up in the class. He was so enthusiastic, that he also brought and demonstrated making custom eyelet hangers. This went well for the snowman and the Santa carvings. Since the student carvers had so much enjoyment in the carving project, the eyelet making will have to be done another day. Michael, thanks for sharing some of the eyelets for the students.

Everyone felt the program was a success. From the NVC volunteers to all the students. We are in the process of developing more class sessions and open demonstrations to be offered at Colvin Run Mill.
