State Projects and Programs

- In 2020, the Louisiana Watershed Initiative's five coordinating state agencies selected 15 projects to receive \$163 million in federal funding.
- The projects were selected because they align with the missions of these agencies and the long-term resilience objectives of LWI. Specifically, the projects will reduce flood risk in communities throughout the state, store floodwaters in ways that enhance natural habitats and move people in flood-prone areas out of harm's way.

Different than Round 1 Projects-Round 1 has not been fully scored or awarded yet

Parish	Award Amount		Project Description
Caddo Parish	\$6.6 million	Black Bayou structure hardening and runoff retention improvements	including replacing the existing spillway with a concrete chute spillway that has control gates to manage the lake level, along with hardening to reduce risk of damage to critical infrastructure (La. Hwy. 2, water line and fiber optic line) during significant runoff events
Grant Parish	\$1.1 million	latt Lake drawdown improvements	including the replacement of one of the existing sluice gates and installation of a new weir gate allowing lake drawdown preceding a forecasted storm event and allowing the water to discharge into the Red River prior to the peak stage

State & Regional Decision-Making Process

March

Applications for Round 1 were due 3/12

April

Regions must set Project Selection Priorities by April 30.

May

- State awards first \$60M and sends unawarded projects to regions.
- Regions begin to review and select projects

July

Regions submit recommendations to OCD



Regional Selection Process



End of April

 State will provide list of projects and a scoring breakdown for each project.

 The region will make a recommendation that cannot exceed \$5 million.

Option A

 The region can select the projects that score the highest under the state's scoring process.

Option B

- If the region does another method, written justification must be provided.
- The RSC must vote on Regional Priorities prior to April 30 to receive the list.



Examples of Regional Priorities

Project Types

Examples:

- Prioritize nature based solutions
- Prioritize green infrastructure
- Make sure to define how you are defining these priorities

Geography

Examples:

- Prioritize projects that impact
 LMI areas
- Prioritize projects that impact HUD MIDs
- Prioritize projects that impact the highest risk flood zones

Project Qualities

Examples:

- BCA ratio
- Social impact
- Low O&M costs


