## Acquisition News

Matlacha Pass Islands Purchased with No Interest, 18 month contract

Martha Peterson, who resides in Matlacha for part of the year, approached me at this past winter's annual meeting and said that she owned two parcels of land that might be of interest to the CLT. Later when I looked them up, she was certainly correct. Shown below are two islands and part of a third that total 120.45 acres.

In my acquisition comments at the annual
meeting I stated that we could not pursue the purchase of additional lands in the near future because of a lack of funding. When Mrs. Peterson realized that, she agreed to sell us the islands for a down payment, and three more payments spaced at 6-month intervals - and with no interest on the unpaid balance! Another member came forward at the annual meeting to say that he was going to make a substantial cash gift

soon. With the cash donation for a down payment, with the favorable terms from Mrs. Peterson, and with a very fair purchase price of $\$ 1,000$ per acre, the board voted to acquire the land. We closed on March 9 and now own these islands.

Note the location of the islands due east of Flamingo Bay. West of the islands are a significant amount of preserved lands owned by us, Lee County 20/20, and the Conservation Foundation of the Gulf Coast. The nearby TITF lands are owned by the State of Florida. This purchase means that all of the islands in Matlacha Pass south of the new bridge and all the way to the LCEC power line are now preserved! And, a huge chunk of land, including all of the old cow pasture, is preserved all the way from Stringfellow Road east to Matlacha Pass.

This latest purchase of just over 120 acres is all mangroves. Mangroves provide excellent habitat for fish and a variety of marine organisms, and they help filter sediment and pollutants from the water. There has been a lot of recent concern about the decline in the water quality of the local estuaries, due primarily to polluted discharges from Lake Okeechobee. The CLT has put a high priority on acquiring mangroves in the last few years because of their critical role in our marine ecosystems, and because they are affordable. We owe many thanks to Mrs. Peterson for offering these islands to us, and to the anonymous donor who provided the down payment that made this purchase possible.



## Great Calusa Poker Run Is Right Around The Corner.

The Calusa Land Trust and Pine Island Boat Club invite everyone to participate in the annual Poker Run on Sunday December 8 th. Following previous year's format, you can draw your lucky poker hands at seven stations accessible by boat or land. Everyone young or old can boat, drive, kayak, walk, run, or take golf carts to enjoy the day and have a chance to win cash prizes. As before, we will finish up at Woody's Waterside to eat, drink, and socialize while waiting for the winning poker hand to be determined.

In addition to all participants having an enjoyable day on the water and on Pine Island, all proceeds will be donated to the Calusa Land Trust and Nature Preserve of Pine Island to help procure and preserve environmentally sensitive land.

The goal of The Great Poker Run is to enjoy the day and collect poker hands at various locations - - speed of completion is not important as long as you draw the $7^{\text {th }}$ card at Woody's before 3:00. Each ticket (you can buy as many as you wish) is carried to six dealer locations around Pine Island Sound and St James City where a card is drawn and entered on your ticket(s). The $7^{\text {th }}$ and final card is drawn at Woody's. If you can' $\dagger$ participate in the Run, your tickets may be carried by someone else. You do not have to be present to win. Best Poker hands will win cash prizes of $\$ 1000$ (first), $\$ 350$ (second), $\$ 150$ (third).

## Summer work parties

On Saturday June 8th we planted around 80 native plants at Fritts Park on Beach Daisy Lane in Bokeelia. We had a good turn out of 14 volunteer rangers and as of now, all the newly planted natives are doing well.

On Saturday July 13th we worked on our Back Bay Preserve in St, James City. We had 6 volunteer rangers working on maintaining the trail that borders San Carlos Bay. This trail I call the Nickerbean Trail after the seemingly impenetrable and thorny nickerbean plant, Caesalpinia bonduc that we encounter along this trail. We are making head way here but will have more follow up work to do in the future. .

August was our vacation month!
On Saturday September 14th we worked at Fritts Park and the canoe trail that leads to our Big Jim Creek Preserve. We had 6 volunteer rangers and we able to reopen the canoe trail which needs almost continuous work to keep open for paddle craft. There was also some weeding and trimming in the park.

Where do you go to view fall colors on Pine Island? Our own Fritts Park is a good place to start - with the fresh crop of native flora recently planted by CLT volunteers. The new natives include several colorful Firebushes (Hamelia patens). Firebush is a showy shrub with bright orange-red flowers, purple and green mottled leaves, and small glossy black fruit. The flashy flowers bloom year round and attract humming birds and butterflies, including zebra longwings, and the berries draw song birds. Firebush is related to coffee and makes a beautiful addition to your yard landscaping. The shrub grows relatively rapidly and can reach a height of about 10 feet. The tubular flowers are about $1 \frac{1}{2}$ inches long, the berries are about $1 / 2$ inch in diameter and the leaves are about 6" long. The plants grow best in partial sun and shade, and can tolerate occasionally wet sand, loam and clay soils, but aren't very tolerant of draught or salt.
 Firebush is commonly available at native plant nurseries and you can propagate it from fresh seeds or cuttings. Some cultures have used Firebush sap and berries in folk medicine to treat a variety of ailments, including rashes. However, it's most enjoyed by watching the butterflies and birds attracted to the bright colors as you look forward to cooler weather on Pine Island.

## Volunteers Needed to Help Monitor Pine Island Sound Water Quality

New volunteers are needed to help collect water quality samples on the first Monday morning of each month at any of 3 sites in Pine Island Sound - including
 Redfish Pass, Blind Pass and Flamingo Bay. Training and equipment are provided, but you must have your own boat. This is an opportunity to enjoy the beautifly early morning quiet on the water and join the comeradery of the nationally recognized Charlotte Harbor Estuaries Volunteer Water Quality Monitoring Network.
