ECA Position on the Proposed Snyder Park Recreation Area

In an effort to be prepared for any potential outcome in reference to My Park Initiative (MPI), Edgewood Civic Association (ECA) is united in its effort to ensure the health, safety, and welfare of Edgewood and to fulfil the mission of Edgewood, "to protect the interests of our community and its residents and to ensure that our neighborhood thrives and is a great place to live, work, and play."

In event of delay or halt of the MPI Snyder Park project:

Some members of the ECA board and association have been actively engaged in every step of the process to oppose My Park Initiative's development project in Snyder Park - and some are active in supporting the initiative. These community efforts were driven by multiple aspects, as well as the significant scale and scope of this project that would forever impact the neighborhood and the community treasure that is Snyder Park. We will continue to pursue a dynamic role in the proceedings regarding Snyder Park, as well as the effects of the expansion of the Nova Southeastern site.

In event of approval of the project to move forward:

If the My Park Initiative project proceeds as presented, the Edgewood Civic Association (ECA) board and members will actively pursue every opportunity to engage with the developers and the city for the most positive outcome for our community. ECA will continue to be an active participant during proceedings.

Five Ash Water Treatment Plant Tour

The city of Fort Lauderdale has approved the construction of a new water treatment plant. The city will begin construction this May 2023, with construction set to finish November 2027. We currently have two water treatment plants serving Fort Lauderdale and the surrounding area. The original plant was built in 1928, with



a second built in 1953 to meet the city's growing population.

The city invited the Edgewood Civic Association to tour the Fiveash Water Treatment Plant on Saturday February 25, 2023. We met with Alan Dodd, P.E. the director of public works for the city of Fort Lauderdale. He and his staff emphasized the necessity of an expanded plant, as well as the technology utilized to meet this need. The tour and staff were amazing, top notch and very competent. They were very happy to meet and welcome us all to their facility.

Despite the age of the plant, 70 years, and the constant operation, the facility was very well maintained; everything was very clean and organized. The control center has 6 large computer screens to view the plant 24/7, 365 days a year. The water is assessed every 30 minutes in the Testing Labs to ensure no contaminants have made the water unsafe for human consumption. The results of the Testing Labs are updated to the control center. Adjustments are made on a minute by minute basis. The plant is run efficiently and assures the water is always safe to drink. The plant is cleaner than my health club!

Outside we were shown a rail road car holding 90,000 gallons of chemicals. There were also nine additional holding tanks with 1,000 gallons each. These tanks supply the chemicals needed to clean the facility's water.

The most impressive aspect of the tour was the pride the employees take maintaining the Fiveash Water Treatment Plant. All this is done with only 30 employees. The budget for this project is 485 million dollars to build the plant, with an additional budget of 180 million dollars for the infrastructure. The updates to the current plant will be able to meet a category 5 hurricane. The

cost of safe, fresh water is estimated to increase approximately 127% over the next 10 years. The new water plant will be located next to our existing wellfields at the executive airport. Public-private partnership P3 to finance the project.

Development Review Committee (DRC) Meeting for New Snyder Park Recreation Center

The Development Review Committee for the City of Fort Lauderdale met on March 28, to discuss the new proposed recreation facility at Snyder Park. Four officers from the Edgewood Civic Association (ECA) attended the meeting and presented neighborhood recommendations and concerns for the project implementation, as had been discussed by the ECA board. The DRC considers technical details only (e.g. parking, traffic, utilities, safety, etc.) on the projects that come before them. This, however, did not prevent a number of attendees from expressing their emotions on the project.

The developer now needs to respond to the comments of the DRC and make any necessary adjustments.

Lets Green Your Routine



Residential Bulk Waste Collection

The Bulk Trash Pickup Program features collection of large household items and tree trimmings, up to 10 cubic yards in size, for residential customers. Items accepted for bulk trash pickup include: appliances, furniture, carpet, mattresses, and toys. Please do not place tires in bulk piles.

Fines

Bulk trash should not be put out for collection more than 24 hours before your collection day. In Edgewood, collection day is the first Thursday of each month. If Code Enforcement officers see any bulk trash out too early, they will spray paint a warning somewhere visible on the pile of bulk trash. If that bulk trash is not removed before pickup, you will be cited with a \$300 fine, that will appear on your City of Fort Lauderdale utility bill.

Schedules and Routes

Bulk trash is collected once per month. **Edgewood's** pick-up is the **1st Thursday** of the month. If you cannot wait for your collection day, you may schedule an appointment for pick-up. There is a fee for this service.

Set Out Instructions

Please place all items at least four feet away from any waste carts, mailboxes, trees, and/or power lines. Avoid blocking storm drains; lay items in such a way as to minimize the likelihood of them blowing over.

Alternatives to Bulk Trash Pick-Up

Often, the items you place in bulk trash can actually be useful to others. Before you throw something away, please investigate whether donating,

scrapping, or otherwise disposing of your old items is a possibility. Find out more here.

Yard Waste

Yard waste, such as tree branches and large quantities of leaves in boxes/bags, may also be set out on bulk collection days.
