Fall is right around the corner and hopefully, that will bring some cooler weather for us here in South Florida. The ECA remains busy keeping tabs on all the projects happening in our neighborhood and around the city. Read on for the latest updates.



PODS Update

City staff continues to work on mitigating the PODS issue, where semi-trucks are using our streets to gain access to the PODS Warehouses on Perimeter Road. Ben Rogers provided the following update:

1. City staff coordinated the installation of new pavement markings to better navigate the turning movements. This was completed in mid-September.
2. City staff submitted signage requests to Broward County for their approval. Broward County is currently reviewing and we are hopeful to have their feedback in the coming weeks.
3. Mr. Rogers has a meeting with the map services provider WAZE. Amongst other things, this will be one of the conversation items (restricting specific routes).

This is great news, and a big thank you to the City of Fort Lauderdale for their continued efforts to help us.

Edgewood Stormwater Upgrades

I received an update from the Public Works Department on the status of our stormwater improvements. The City had the bid opening on July 27th and anticipates awarding this project to the low bidder in October (assuming no-bid protests). Once the project is awarded, they anticipate construction will start in early 2022.

Once the project is awarded the City will engage the neighborhood about the upcoming work and any concerns we may have.

I will continue to get updates, and once the project is awarded, organize a

meeting at the clubhouse so everyone can participate.

Rosewood Villas

As some of you already know, the property on SW 15th Ave and SW 32nd Ct (3303 SW 15th Avenue) was purchased. The property owners recently gave a presentation to the neighborhood at our clubhouse. Fourteen contemporary townhouse-style units, each with a two-car garage.

They've planned for guest parking, trash receptacle storage, and a stormwater storage area. Additionally, each unit will have its own entrance off the main street.

Florida Department of Environmental Protection

The Florida Department of Environmental Protection is the state's lead agency for environmental management and stewardship, protecting our air, water, and land. DEP is divided into three primary areas:

- **Land and Recreation** programs acquire and protect lands for preservation and recreation. DEP oversees 175 state parks and trails and more than 12 million acres of public lands and 4 million acres of coastal uplands and submerged lands.
- **Regulatory** programs safeguard natural resources by overseeing permitting and compliance activities that protect air and water quality and manage waste cleanups.
- **Ecosystems Restoration** programs protect and improve water quality and aquatic resources including America's Everglades, Florida's iconic springs, and Florida's world-renowned coastal resources. DEP works with communities, local governments, and other agencies to protect and restore water quality and supply and to provide funding assistance for water



restoration and infrastructure projects, as well as coordinates the protection of Florida's submerged lands and coastal areas.

How can DEP help you?

- **Compliance assistance:** The department helps residents and businesses comply with environmental regulations through site visits and technical support. DEP's six regulatory district offices review permit applications, inspect permitted facilities, respond to reports of environmental damage, and conduct compliance assistance and enforcement.
- **Education and information:** You can sign up for a variety of digital newsletters, updates, and announcements about the department's programs, activities, and events.
- **Recognizing environmental stewardship:** DEP encourages sound environmental practices through its sustainable initiatives programs, including Clean Marinas, Green Lodging and Recycling Recognition.
