General Membership:

Initiation Fee: \$1,000.00 (a non-refundable check to be cashed upon application) in 2025.

The initiation fee is non-refundable (unless membership is denied) & is non-transferable. There currently is a waiting list, estimated time to reach membership is 2-3 years.

Dues: \$103 per month (This is the 2025 rate, this will change annually for COLA).

Volunteers: Missouri Yacht Club is a volunteer organization with a volunteer board. We count on our

membership to serve on committees from time to time and/or the board when asked. We

look forward to your participation.

Locker Fees: Optional: \$50.00 per year in 2025, will be billed to your account. Please request a locker.

Minimum House Bill:

Food expense minimum of \$200 (2025 rate) per calendar year will be enforced. Food expenses include the snack bar, all upstairs dining, and dining room setups. Members will be assessed the difference in their food bill at the end of the year. Memberships terminated mid year will be assessed their prorated food minimum with their final dues bill.

One Year Minimum:

Please be advised that all memberships are One Year Minimum, should you decide to cancel your membership in the first year you will be billed the remaining monthly dues (equal to twelve months) along with the minimum house bill (as outlined above).

Resignations:

All resignations must be submitted in writing to the Missouri Yacht Club Membership Directory. Thirty (30) days notice must be given. All outstanding dues and yearly minimum shortage will be immediately due.
