

Parent Contract

- 1. I understand that I must pay a non-refundable application fee of \$100 plus a non-refundable deposit of \$350 in order to secure a space for my child at Robots and Mud Pies π Preschool (RAMPP) for the coming school year.
- 2. I agree to pay tuition in nine (9) monthly payments or one annual payment. These monthly payments are due on *or before* the 1st of each month through May.
- 3. Late payment of tuition will result in a late fee of \$10.00 if tuition is not paid by 4:00 p.m. on the 5th day of the month. Parents will pay any bank charges related to checks that are returned by the bank or other payments that cannot be processed.
- 4. I understand that I will be given a dismissal time based on my child's classroom. I will pick up by the end of carpool time. A fee of \$15.00 will be charged after 5 minutes after the carpool ends unless prior arrangements have been made. Repeated late pick-ups may result in dismissal from RAMPP.
- 5. If RAMPP must close due to COVID-19 or another emergency situation, I will pay the regular tuition rate for 2 weeks.
- 6. If I must withdraw my child from RAMPP, I will give a paid, written thirty (30) day notice.
- 7. Tuition payments will not be refunded for absences or closings. There are no make-up days for missed days.
- 8. RAMPP reserves the right to terminate this contract if payments are not made on time or for any other reason. Tuition payments that have already been paid are non-refundable.
- 9. I agree to submit all required paperwork by the date of the August Open House (see calendar) or before my child's first day of preschool if starting after the first week of September.

10. I agree to read the RAMPP Parent Handbook (online). I will ask questions if I am unsure of any policy. My child will attend RAMPP for the following session(s) at the following tuition rates.
