1. We want a Senate Judicial Committee ‘informational hearing,’ with every county election official, on the election procedures and processes.
2. How many people registered to vote in the illegal 10-day extension and voted, in every county.
3. How were these new registrations processed?
4. We want to know the ‘illegal votes’ in every county.

### **Details**

#### Illegal Votes

AZ had an illegal 10-day extension that allowed voter registration in 200 – due to COVID. 33,000 new voters registered. AZ has a law that you must register to vote 29 days before you vote. At the last Senate hearing the Liaison Secretary Ken Bennett said there were close to 4,000 people who registered to vote in this 10-day extension and then voted, in just Maricopa County. This is an illegal vote.

- How many were there in Pima and Pinal? Every county needs to show their numbers.

- How many people registered to vote in the illegal 10-day extension and then voted.
- How many early ballots were processed everyday.
- How many staffers each day in every location?
- How many minutes were given to process each early envelope?
- How many minutes were given to process each registration ?

#### Bottom Line

We have been waiting 5 months for the vendor to complete the hand count and enough is enough. The Legislature has oversight authority of the executive branch and Constitutional authority to oversee the elections. Did you see CA is allowing people to print their own ballots? We have too many Legislators 'Running to the Sounds of the Headlines' and fundraising off the audit and they need to stop and DO SOMETHING about our election procedures.
