The Vendor further agrees to fully indemnify, defend, save and hold harmless, the HSWC in respect to any injuries suffered by Vendor's employees, agents, guests, customers, or invitees of Vendor's, in connection with every claim, charge, loss, damage, judgement, deficiency, settlement, liability, expense and injury (including, but without limitations attorney's fees) suffered or incurred, or which would be suffered, paid for or incurred by Vendor in connection with any and every claim, demand, right or cause of action of whatever kind or nature either in law or in equity, arising from Vendor's use and presence or entities other than the HSWC.

The Vendor individually and on behalf of any of the Vendor's employees, agents, guests, customers, or invitees, hereby waives all rights to sue the HSWC for any reason whatsoever, including but not limited to, condition of the property, acts of persons on entities other than the HSWC.
