

Suggested Correspondence before submitting an exemption for the Covid-19 Vaccine Mandate

- Request your employers Covid-19 Mandate company policy to be sent in writing to you in a format where you can save it, such as email or certified mail.
- Consider emailing the employer in writing several questions asking them to provide you in writing points such as: the law that was passed by Congress that states they have the legal authority to require this or terminate an employee if they refuse, safety information including all adverse events reported and all ingredients in every Covid-19 vaccine available, liability information for who is liable if you sustain injury & 100% proof that you will not be harmed by taking the vaccine.
- ➤ Get all correspondence in writing. Save and Document everything. If you are using an internal system save the correspondence.
- > Provide a deadline for their response. Keep all communication records saved in writing.

Tips on preparing your own religious exemption letter

- Draft your own written letter that states how/why the Covid-19 Vaccine is against your sincerely held personal religious beliefs.
- ➤ Use the Employers written policy and responses to any questions you have in writing from them as points to bring up in your letter.
- ➤ Health Freedom PA has a sample formatting letter attached to this document to help you format and prepare to <u>write your own letter</u>. This sample should not be used as <u>an exemption letter</u>. This is for educational reference information only.
- It is up to you on how much information to provide on your letter. Providing a sentence or two as to why it is against your beliefs may provide the best possible outcome.

How to Request an <u>Attorney Letter to go along with</u> your religious or medical exemption letter.

- This Letter is intended to be in addition to your own letter and will be sent directly to your employer /college. This intent of the Attorney letter is to inform them of the law on your behalf regarding your exemption you submitted.

- ➤ Include your <u>last name</u> in the subject line along with <u>"Attorney Exemption Letter</u> Request"
- Let Attorney Stapp know that Health Freedom PA referred you.
- Please list in the email your employer's contact information for where the letter should be sent and any details that may be relevant and/or information from your employer.
- Include when you have or will submit your own letter and provide a copy for reference if available although not required. Your letter must be sent before or simultaneously.
- ➤ By requesting this letter, <u>you are aware and acknowledge that there is a fee of \$125</u> for the letter

If your exemption has been denied, also follow these steps.

- Find out if there is an appeal process and if so, appeal as many times as allowed in hope of getting your exemption on file to be accepted. Even if your company has no formal appeal process you may still appeal.
- ➤ Phase 2: Find other employees that are in the same position if possible. Contact an Attorney to represent you or the group in filing a complaint for preliminary injunction to attempt to stop the employment Termination. If not successful move to next step. Attorney Greg Stapp mentioned above is one Attorney that you may contact.
- ▶ Phase 3: After Discharge of employment, proceed with your Attorney in filing suit. Having a group of employees will make a stronger case.
