

BYLAW #2017-1

A BYLAW TO FIX THE RATES TO BE CHARGED FOR THE USE AND CONSUMPTION OF WATER AND TO FIX THE RATES TO BE CHARGED BY WAY OF RENT OR SERVICE CHARGE FOR THE USE OF SEWER

THE COUNCIL of the Rural Municipality of Calder No. 241, in the Province of Saskatchewan, enacts as follows:

SHORT TITLE

1. This Bylaw may be cited as the "Water & Sewer Rate Bylaw".

LEGAL REQUIREMENT

2. This bylaw has been created to comply with Section 23(3) of *The Municipalities Act*.

WATER USE & CONSUMPTION RATES:

3. The charges to be paid by the water consumer whose water service has been turned on shall be those set out in Schedule "A" attached; provided, however, that the minimum shall be payable in every case whether or not any water is consumed.

SEWER RENT OR SERVICE CHARGE:

4. Persons who own or occupy premises drained or that are by bylaw required to be drained into the sewer shall pay for such services a rental rate or service charge in accordance with Schedule "B" attached.

WATER & SEWER ACCOUNTS:

5. Accounts for water service and/or sewer service shall cover a period of one month, unless otherwise specified on Schedule "A" and Schedule "B", and shall be rendered on or before the first day of the month next following such period. Accounts shall be paid within a period of thirty days from the date on which such accounts are rendered.

ACCOUNT NON-COMPLIANCE:

6. If an account is not paid within the period of thirty days, the water service may be cut off. When the water service is cut off, it shall not be turned on until all arrears have been paid, together with a fee of \$200 (two hundred dollars) to cover the expenses of turning off the water and turning it on again.
7. A penalty of \$15.00 per month for each month the bill remains outstanding will be charged on unpaid accounts.
8. All water and sewer accounts that remain outstanding as at December 31 shall be added to the tax roll.

ANNUAL PREPAYMENT DISCOUNT:

- 9. Any account wishing to prepay their annual water and sewer fees in full within 31 days of the coming into force of this bylaw for the year 2016 and subsequent years on or before the 31st day of January in the year to which the services are due shall be entitled to a 10% discount off the water and sewer rates stated in Schedule A and Schedule B of this bylaw.

REPEALING OF BYLAWS:


- 10. Bylaw No. 2004-1 is hereby repealed.

- 11. The rates, charges, tolls or rents contained in this bylaw shall come into force and take effect on the day of approval being issued by the Saskatchewan Municipal Board.
