## A BYLAW TO REGULATE FIRE WORKS WITHIN THE HAMLET OF WROXTON

---

The Council of the R.M. of Calder No. 241, in the Province of Saskatchewan enacts as follows;

### 1. TITLE:

This Bylaw maybe cited as the Fire Works Bylaw within the Hamlet of Wroxton.

### 2. PURPOSE:

This bylaw of the Rural Municipality of Calder No. 241 in the Province of Saskatchewan is for the purpose to regulate Fire Works within the Hamlet of Wroxton.

### 3. DEFINITIONS:

1. In this Bylaw:
  - a) "Chief" means the Chief of the Fire Departments for the R.M. of Calder No. 241, or such other person who may be appointed by Council to carry out the provisions of this bylaw;
  - b) "Council" means the Council of The Rural Municipality of Calder No. 241.
  - c) "FIREWORKS DISPLAY" - A display of fireworks for the entertainment of the public at large.
  - d) "Fire Works" means- Firecrackers, rockets, squibs, torpedoes, roman candles, or any other objects or substance designed to be exploded or burned to produce noises or brilliant lighting effects.
  - e) "Hamlet of Wroxton" mean the Hamlet within the Boundaries of the R.M. of Calder No. 241.

### 4. FIREWORKS

a) No person shall set off, detonate, ignite, or cause to be ignited, any fireworks within the boundaries of the Hamlet of Wroxton at any time whatsoever, provided that this section shall not apply to a fireworks display.

b) The Council, at their discretion, may issue a permit in writing, as shown in **Schedule "A"** of this Bylaw, authorizing a fireworks display for a special Occasion in the Hamlet of Wroxton.

FEES FOR THE PERMIT WILL BE \$ 25.00 PER APPLICATION

c) A permit issued under (4.)(b) shall prescribe to the conditions which a display of fireworks may be held in the Hamlet of Wroxton, and no person shall conduct a display of fireworks in contravention of such prescribed conditions.

d) The fireworks must be held at a safe distance from all combustible materials and all highways, overhead wires, buildings, and other structures.

e) The fireworks must be conducted in a safe manner so that all spectators are at a safe distance and suitable fire extinguishers or other proper means of fire suppressions are at hand.

f) The fireworks must be completed no later than 11:00 p.m.

g) The Council, Bylaw Enforcement Officer, or the Fire Chief may temporarily or permanently suspend or terminate any fireworks or fireworks display if:

- a). It is deemed threatening or becoming a danger to any property or to public health or safety.
- b). It is inadequately equipped with fire safety or suppression equipment;
- c). Written approval from Council has not been obtained.

h) All unused fireworks and debris created by the fireworks must be safely removed and disposed of immediately after the display.

i) The permitted is responsible for any or all damages as a result of setting off fireworks.

### 5. PENALTIES

1. Every Person who contravenes any provision of this Bylaw is guilty of an offence and is liable on summary conviction to:
  - (a) A minimum of Two Hundred and Fifty Dollars (\$ 250.00) for a first offence; and
  - (b) A minimum of Five Hundred Dollars (\$500.00) for a second or subsequent offence.
2. Upon receipt of notice of violation, full payment must be received by the Municipality within Fourteen (14) days from the date of notice.

### 6. ENFORCEMENT:

1. A Municipal Bylaw Enforcement Officer or member of the Royal Canadian Mounted Police have the authority to serve violation notice on any such person they believe to have breached the conditions of this Bylaw.
2. The Fire Chief, Municipal Council and or the Municipal Bylaw Officer, has the authority to disallow any fireworks within the Hamlet of Wroxton, which is deemed dangerous or which does not adhere to the articles in this bylaw.

### 7. AUTHORITY

1. WHEREAS Section 8(1)(b) of *The Municipalities Act* provides general power to pass any bylaws for the purposes of the municipality that it considers expedient in relation to matters respecting the safety, health and welfare of people and the protection of people and property;
2. Nothing contained in this Bylaw shall relieve any person from complying with all relevant laws, regulations or bylaws and in particular, with the provisions of The Air Pollution Control Act, The Saskatchewan Fire Code Regulations, The Fire Prevention Act, 1992 of the Province of Saskatchewan and the regulations passes pursuant thereto.
