BYLAW #2017-11

A BYLAW TO ESTABLISH PENALTIES FOR THE CONTRAVENTION OF BYLAWS

THE COUNCIL of the Rural Municipality of Calder No. 241, in the Province of Saskatchewan, enacts as follows:

SHORT TITLE:

This Bylaw may be cited as "General Penalty Bylaw"

AUTHORITY:

2. This bylaw is made IN ACCORDANCE to Section 381 of The Municipalities Act.

DEFINITIONS:

- 3. In this Bylaw:
 - a) "Municipality" shall mean the Rural Municipality of Calder No. 241;
 - b) "Designated Officer" shall mean the Administrator or other person designated by resolution of Council.
 - c) "Council" shall mean the Council of the Rural Municipality of Calder No. 241.

SCOPE OF BYLAW:

 This bylaw shall apply only with respect to an infraction of a bylaw of the municipality for which no other penalty is provided.

GENERAL PENALTIES:

- Every person who contravenes any provision of any bylaw of the municipality is guilty of an offence and liable on summary conviction:
 - a) in the case of an individual:
 - to a fine not exceeding TEN THOUSAND DOLLARS (\$10,000) and, in the case of a continuing offence, to a further fine not exceeding TWO THOUSAND FIVE HUNDRED DOLLARS (\$2,500) for each day during which the offence continues;
 - ii. and/or to imprisonment for not more than one year;
 - b) in the case of a corporation:
 - to a fine not exceeding TWENTY FIVE THOUSAND DOLLARS (\$25,000) and, in the case of a continuing offence, to a further fine not exceeding TWO THOUSAND FIVE HUNDRED DOLLARS (\$2,500) for each day during which the offence continues.
