ORDINANCE #02-FY2021LVY

ORDINANCE LEVYING AND ASSESSING TAXES OF THE GOLFVIEW HILLS PARK DISTRICT, DuPAGE COUNTY, ILLINOIS FOR THE 2021 TAX LEVY YEAR

BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS OF THE GOLFVIEW HILLS PARK DISTRICT, DuPAGE COUNTY, ILLINOIS:

Section 1. That the sum of:

Forty Thousand Three Hundred Dollars (\$40,300) for the General Corporate Fund; Five Thousand Dollars (\$5,000.00) for the Recreational Program Fund; Six Hundred Dollars (\$600.00) for the Liability Insurance Fund; Six Hundred Dollars (\$600.00) for Municipal Auditing Fund,

be, and the same are assessed and levied from and against all taxable property within the limits of said Golfview Hills Park District as the same is assessed and equalized for state and county purposes for the current year (2020). The said taxes, which are hereby levied, are exclusive of the amounts previously levied for the payment of bonded indebtedness and interest thereon. Said taxes are hereby levied for the 2021 tax levy year, and the specific amount hereby levied for each object and purpose is set forth under the column entitled: "Amount to Be Raised By Tax Levy for FY 2021".

<u>Section 2:</u> The unexpended balance of any item or items levied in and by this ordinance may be expended in making up any deficit of any item or items in the same general appropriation and levy made by this ordinance.

Section 3: That the secretary is hereby authorized and directed to file a certified copy of this ordinance with the County Clerk of DuPage County within the time specified by law. 70 ILCS 1205/5-1.
