## ORDINANCE NO. #01-FY2022BA

### **BUDGET AND APPROPRIATION ORDINANCE**

# AN ORDINANCE ADOPTING THE COMBINED ANNUAL BUDGET AND APPROPRIATION OF FUNDS FOR THE GOLFVIEW HILLS PARK DISTRICT, Du Page COUNTY, ILLINOIS

FOR THE FISCAL YEAR 2022 BEGINNING ON JULY 1, 2022 AND ENDING ON JUNE 30, 2023

## BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS OF THE GOLFVIEW HILLS PARK DISTRICT, DuPAGE COUNTY, ILLINOIS

**SECTION 1.** It is hereby found and determined that:

- a) This Board has heretofore caused to be prepared a combined Annual Budget and Appropriation for FY 2022 in tentative form, which Ordinance has been conveniently available for public inspection for at least 30 days prior to final action thereon; and
- b) A public hearing was held at the Indian Prairie Public Library, 401Plainfield Road, Darien, Illinois 60561 on November 11, 2021 on said Ordinance, notice of said hearing having been given at least one week prior to such hearing by publication in Golfview Hills Newsletter, as published within the Park District; and
- c) That all other legal requirements for the adoption of the Annual Budget and Appropriation Ordinance of the Park District for the **Fiscal Year 2022 beginning July 1, 2022 and ending June 30, 2023** have heretofore been performed.

**SECTION 2.** The following sums of money, or so much thereof as may be authorized by law for the following objects and purposes, be and are the same are hereby budgeted and appropriated for the **Fiscal Year 2022**, beginning on July 1, 2022 and ending on June 30, 2023.
