I further certify that said Ordinance was passed in compliance with the provisions of "The Truth in Taxation Law," 35 ILCS 200/18-55 through 18-100.

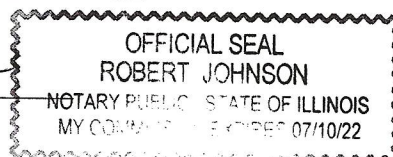

**ORDINANCE LEVYING AND ASSESSING TAXES OF THE
GOLFVIEW HILLS PARK DISTRICT,
DuPAGE COUNTY, ILLINOIS, FOR THE
2019 TAX LEVY YEAR**

BE IT ORDAINED BY THE BOARD OF PARK COMMISSIONERS OF THE
GOLFVIEW HILLS PARK DISTRICT, DuPAGE COUNTY, ILLINOIS:

Section 1. That the sum of Forty-Three Thousand Three Hundred Seventy-Nine Dollars (\$43,379.00) for General Corporate Fund; the sum of Fourteen Hundred Ninety-Five Dollars (\$1,495.00) for the Recreational Program Fund; the sum of Six Hundred Two Dollars (\$602.00) for the Liability Insurance Fund; the sum of Six Hundred Two Dollars (\$602.00) for Municipal Auditing Fund, be, and the same are assessed and levied from and against all taxable property within the limits of said Golfview Hills Park District as the same is assessed and equalized for state and county purposes for the current year (2018). The said taxes, which are hereby levied, are exclusive of the amounts previously levied for the payment of bonded indebtedness and interest thereon. Said taxes are hereby levied for the 2019 tax levy year, and the specific amount hereby levied for each object and purpose is set forth under the column entitled: "Amount to Be Raised By Tax Levy".

Section 3: That the secretary is hereby authorized and directed to file a certified copy of this ordinance with the County Clerk of DuPage County within the time specified by law. 70 ILCS 1205/5-1.

Section 4: This ordinance shall be in full force and effect ten (10) days from and after its passage and approval as required by law.

Section 5: The invalidity of any portion of this ordinance shall not render invalid any other portion of the same, which can be given effect without the invalid part.
