#### Legislative Report

With the legislature switching over to a virtual session, and with physical face to face meetings by citizens with legislators inside the legislative facilities currently not allowed, the legislative team of ABATE will have to adapt and overcome these obstacles and focus on telephone and email contacts. Even the floor sessions and committee hearings will be held online. That means we will be testifying online in any hearings that our bills get, and the hearings will be viewable on TVW ([tvw.org](http://tvw.org) if TVW isn't part of your television channel package) as they happen. Even most of the legislators will be working from home, or their district offices, with some working from their legislative office in Olympia. At the time of this writing, the Legislative Information Center has not published a listing of legislative members or their contact information yet. As soon as possible, ABATE will distribute the information to its membership in order that members can contact their legislators in support of our efforts this year. It is crucial that members contact their legislators via telephone and email to show support for our issues, since our ability to meet face to face at the Capitol this year is being blocked due to COVID.
