



Did you know?

The IRS Delays Tax Change for Users of Digital Payment Platforms

If you receive income from parents or others through digital payments like CashApp, Venmo, or PayPal, you will have another year before you have to comply with a new IRS tax rule requiring that users receive a 1099K form if they earn at least \$600 in payments on one of these apps for goods/services. The previous law - now in place for another year - requires the form be sent only to users earning \$20,000 or more.

With this change, **you will not receive a 1099K form this year unless you earn more than \$20,000, BUT, you are expected to report all income on your taxes.**

¿Sabías? El IRS retrasa el cambio de impuestos para los usuarios de plataformas de pago digital

Si recibe ingresos de sus padres u otras personas a través de pagos digitales como CashApp, Venmo o PayPal, tendrá otro año antes de tener que cumplir con una nueva norma fiscal del IRS que exige que los usuarios reciban un formulario 1099K si ganan al menos \$600 en pagos en una de estas aplicaciones para bienes/servicios. La ley anterior, ahora vigente por otro año, requiere que el formulario se envíe solo a los usuarios que ganan \$ 20,000 o más. **Con este cambio, no recibirá un formulario 1099K este año a menos que gane más de \$20,000, PERO, se espera que declare todos los ingresos en sus impuestos.**

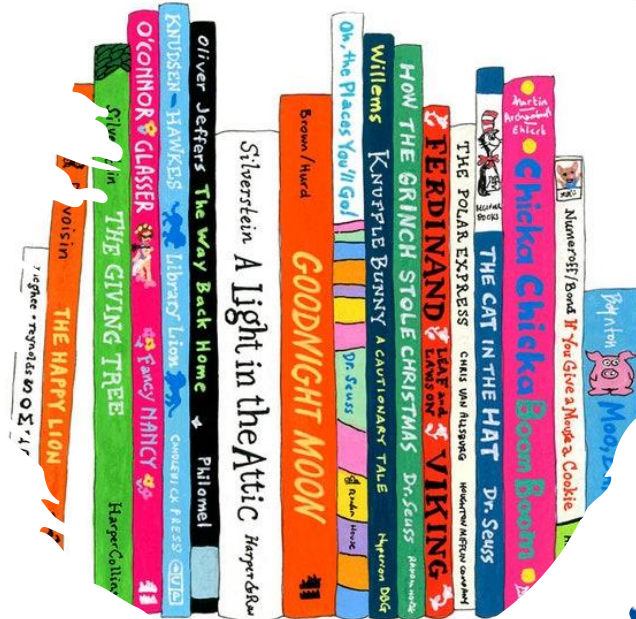
