

We had a very good discussion on labor issues and stated he would like to see the GCSAA develop more Spanish education webinars to aid with training and advancing members of his crew. We then discussed the First Green program and the benefits of doing them. We then toured The Manakin course which they had just renovated the tees, fairways and roughs into Latitude Bermuda grass and greens to Triple Seven. They were going to do the other course next year and put in Latitude Bermuda on tees, fairways and roughs and Pure Eclipse on the greens.

My next stop was at the Independence Golf Club. They have an 18 hole "Champions" and a 9-hole course "The Bear". There I had the opportunity to spend some time with Dr. McCall and Travis Roberson (Graduate Research Assoc.) from Virginia Tech where they do research for warm season grasses. During the tour of the research plot's, we were able to discuss the challenges they have with getting turf students into the program at Virginia Tech as preferences are given to engineering students. Later we meet up with Dan Taylor (Superintendent) and had lunch. We discussed the unique "The Bear" course, 9 holes, which is set up for Golf, Disc golf and footgolf. The Bear has a course called the CANOPY which goes through the trees of the course which has different levels of rope courses to challenge you and zip lines.
