Additional guidance for FMS ranking was sent out on April 27,2023. Which outlines requirements for recommended FMS to be included in the ranking list.

6. Discussion and possible action – Update on Task 12 Activities by Bryan Martin HDR In January 2023 Final Flood Plan defined FMXs for each county. There were several maps produced in 2023. The first one was showing flood risk maps that was showing flood inundation. The second one showed flood risk scores and showed the highest flood needs along with FMXs and a list showing all the FMEs, FMPs, and FMSs in each county in the 2023 plan. In Task 12 additional outreach and advancement of FMXs. Resulting in additional refinement and recommended FMXs. The list from 2023 has been revised and under consideration for advancements or inclusion in 2024 revised plan. New in task 12 is the 1-page summaries on new FMXs and technical memorandums will be included in the revised. There was a Task 12 FMX advancement log sent out 5/8/2023 to the planning group with updates. There are about 99 FMEs or FMPs to advance through task 12 that will happen in the revised plan. You can use this log as a change log from task 12 since 2023 plan. Included is a table with all FMXs sponsored per county final vs. revised plan. There will be 33 FMPs and several FMEs that have been added to the revised plan. Counties with new FMXs are as follows, Aransas County FMEs was a wide flood study. Atascosa, Bexar, Karnes, Wilson Counties have 2 FMEs advance to FMPs which are Jourdanton Drainage improvements and detention ponds and Poteet Drainage improvements. Duval County master plan FMXs identified and advanced San Diego with 5 FMEs but no adverse impact or resolved. Benavides has 2 FMEs advances to FMPs which are Las Animas Conveyance Infrastructure and Main City Network Storm Drain Improvements. Frio County has 2 FMPs which are North Pearsall Drainage improvements and CR 1520/Tehuacana Rd. and 4 FMEs which are CR 3000/Keystone Rd., CR 4757/Leona River Rd., Countywide Bridge repair, and CR 3300/s Goldfinch Rd. In Pearsall there was 4 FMPs regional det. Pint in Davila St. Trib, Storm sewer bypass improvements in Trinity St Trib from trinity St. to Radio Rd., Detention ponds in the Pearsall High school grounds, and Channel lining and conveyance improvement along FM 1581. Kleberg has 4 FMEs which are location 2 at 19th St. from E. Lott Ave. to Maple St, location 5 Caesar Place Subdivision, location 9 N 17<sup>th</sup> St, Corral Ave intersection and Carriage Park 2 Subdivision improvements. Maverick and Zavala there was 1 FMP for the drainage improvements from the school to the park. Medina County in the City of Lytle added 1 FMEs in Lake Shores Estates Master Drainage Plan and then in the City of Devine added 1 FMPs in Burnt Boot Creek Drainage Improvements. Nueces County 1 FME funded and changed to on going project, 2 FMEs advanced to FMPs which are Corpus Christi Kinney St. Pump Station and Corpus Christi

Power St Pump Station. Tri-County Master Plan added 15 new FMPs and 19 FMEs. Real and Kerr Counties in the town of Camp Wood are working to define 1 FMPs and added 2 new FMEs in Real County at McDonald Crossing of Plumin Creek near the Nueces River and Bajo Camino Low Water Crossing. San Patricio added 5 FMPs in the City of Gregory, Taft, Odem, Sinton, Mathis, and 10 FMEs. Sarah West from Freeze & Nichols stated there could be a potential negative impact were noted based on provided data, working with CDM-Smith to verify or clear the potential impacts. If negative impacts cannot be cleared up this will become a new FME instead of an FMP. The last county is Uvalde which has 6 new FMEs which are various flood warning gages, 7 Bluff, Kenneth Crossing, Avant Crossing all on the Frio River near Concan, Cr 348 on Bear Creek, and Indian Creek Crossing. The Counties that had no change in FMXs are Bandera, Bee, Goliad, Dimmit, Edwards, Jim Hoff, Brooks, Jim Wells, Kinney, LaSalle, Live Oak, McMullen, Refugio, Kerr, and Webb. You can review the FMXs advancement log in task 12 for more information on all 99 FMXs.
