 - Total Bank Balance \$49,811

- By Laws on voting: (just for ease of access)
 - Yearly elections shall be conducted to elect the officer positions for the Board of Directors. Nominations for these positions shall be <u>opened in January</u>, <u>closed in March</u> and <u>elections shall be held in April</u>. Anyone from the general membership is allowed to make nominations to the current Board of Directors in writing. A member(s) from the standing Board of Directors shall communicate with each individual who has been nominated making sure that the individual understands the expectations of the position. Once the nominee understands these expectations, confirmation of the nominee's acceptance or denial shall be made in writing. The Board of Directors will compile the entire list of nominees, the list of nominees will be presented to the general membership with a minimum of 48 hours notice prior to the vote, and the elections will be held by a vote of the general membership. The results of the elections will be published/announced to the general membership at the close of the vote.

- The directors are working to transition from contra tubas to sousaphones.
 FHS will be trading with West HS FHS's current inventory of the contra tubas for West's inventory of sousaphones, six for six, but that still leaves two short.
- There are top of the line King Sousaphones that were used one week in preparation for the Macy's Thanksgiving Day Parade. They are brand new and have all of the parts with them, including cases. The cost is \$6495 per instrument, and that is roughly 60% of the MSRP.
 - For an understanding the sousaphone is most often played in marching bands and helps project the sound and as they wrap around the body they are more comfortable when standing.
- The cost to purchase two of these plus shipping is \$13,500.
