

DUES RATES AND FEES

RATES VALID THRU 12/31/2020

\$28 JOURNEY-LEVEL/APPRENTICE/PRE-APPRENTICE

Any Journey-Level, Apprentice or Pre-Apprentice that **did NOT opt-out** of the MetLife Insurance benefit in 2017 pays the standard rate of \$28.00 per month. To maintain eligibility for the MetLife benefit, you must remain a member in Good Standing status.

\$23 JOURNEY-LEVEL/APPRENTICE/PRE-APPRENTICE

Any Journey-Level, Apprentice or Pre-Apprentice that **did opt-out** of the MetLife insurance benefit in 2017 pays \$23.00 per month.

\$21.80 SHORT-TERM DISABILITY (includes MetLife)

Please contact the Local 322 office at 651-379-0272 for more information on how to apply for this reduced rate. To maintain eligibility for the MetLife benefit, you must remain a member in Good Standing status.

\$16.80 EARLY RETIRED (LESS THAN AGE 65/LESS THAN 30 YEARS CONTINUOUS SERVICE)

Members paying this rate are collecting a Carpenters pension and are not working

\$6.00 RETIRED/SOCIAL SECURITY DISABILITY (AGE 65 OR OLDER AND 30 YEARS OR MORE OF CONTINUOUS SERVICE)

Members paying this rate are collecting a Carpenters pension and are not working. They are age 65 or older and have 30 years or more continuous service.

Members receiving Disability benefits from the Social Security Administration are eligible for a reduced rate of \$6.00 per month. Just send in your award letter from the SSA to Local 322 to apply.

\$29 JOURNEY-LEVEL/APPRENTICE/PRE-APPRENTICE (INCLUDES METLIFE)

\$23 JOURNEY-LEVEL/APPRENTICE/PRE-APPRENTICE (NO METLIFE)

\$22.80 SHORT-TERM DISABILITY (includes MetLife)

\$16.80 EARLY RETIRED (LESS THAN AGE 65/LESS THAN 30 YEARS CONTINUOUS SERVICE)

\$6.00 RETIRED/SOCIAL SECURITY DISABILITY (AGE 65 OR OLDER AND 30 YEARS OR MORE OF CONTINUOUS SERVICE)

LATE FEES

Any time you fall behind 3 or 6 months, you will be charged a \$5.00 late fee on the 15th of that month. If your payment is received by the end of business on the 15th, the late fee will be removed.

DUES ARE CHARGED TO EACH MEMBER'S ACCOUNT ON THE 1ST OF EACH MONTH. DUES FOR THE CURRENT MONTH SHOULD BE PAID BY THE LAST DAY OF THAT MONTH.
