

# Lions of Wyoming Foundation

### **MISSION**

It is the specific mission of the Lions of Wyoming Foundation to provide quality programs and services to the people of Wyoming for the detection, treatment and rehabilitation of visual impairments and others with special needs. The Foundation solely, or in conjunction with Lions Clubs, foundations and/or other organizations shall provide its assistance through grant processes or delivered through direct or indirect programs and services.

### **OBJECTIVES**

- 1. To provide quality programs and services for the treatment of sight related problems for the citizens of Wyoming.
- 2. To provide assistance for the unmet medical needs associated with sight and hearing.
- 3. To provide assistance for activities and services for those with disabilities.
- 4. Provide other grants under special circumstances.

The Lions of Wyoming Foundation is the "Charitable Arm of Wyoming Lions." It is our goal to support Lions projects in Wyoming. We also encourage support of Lions projects in the region, the nation and the world. The major focus of the Foundation is to assist local Clubs with humanitarian projects that require more funding than the club can support on its own. We provide assistance for clubs in applying for grants from the Rocky Mountain Lions Eye Bank Surgical Fund and the Rocky Mountain Lions Eye Institute Foundation's Travel Assistance Fund. We partner with clubs to provide the match for such grants, brokering cooperation between the local club(s), our Foundation, and other grant funding organizations. Since becoming the owner of the Allen H. Stewart Lions Camp in 2012, the LoWF has an additional important role: assuring that funding will be in place to underwrite Camp operations and the annual, one-week long Summer School for Visually Impaired Youth.

## 2020 Highlights

For the second consecutive year the Summer School at the Allen H. Stewart Lions Camp was cancelled. This time it was due to the COVID-19 Pandemic. The Camp Board took advantage of being closed for campers to complete a number of infrastructure improvements and repairs.

A total of \$2,972.23 was awarded in patient assistance grants in 2020. Seven cataract surgeries (2 double cataracts) were performed utilizing grant funding from the Rocky Mountain Lions Eye Bank (\$10,266.02). Local Clubs matched the \$2,972.23 provided by LoWF.

The Lions of Wyoming Foundation has had three negative income years in succession. It is extremely important that we discover strategies for increasing the financial support of the LoWF. The Foundation continues to seek fundraising strategies that will derive more funds from the general public, and be less dependent on our Lions Clubs. Of course, the Camp alson needs the continued financial and Lion-power support of our Wyoming Lions as well.



### Executive Director Dave Orr Retires

2020 saw the retirement of long-time Executive Director, PDG David Orr. Lion Dave became E.D. in the Fall of 2004 when his predecessor, PID John Daum moved to South Dakota. Lion PDG Mindi Crabb (Pinedale Lions Club) began her duties as the new Executive Director in the summer, and

assumed full duties following a three-month transition. Sadly, Lion Mindi was forced to resign at the end of the year due to medical concerns. Lion Dave resumed his duties on an interim basis following Mindi's resignation. The search for another replacement began at that time.
