



## **Facebook**

As promised, here are the <u>FAQs</u> on the new economic recovery grant program for small tourism, hospitality and retail-related businesses that will be available beginning Wednesday, <u>December 2</u>. Please read this information for the full details on eligibility.

#### IMPORTANT POINTS:

- This is a first-come, first-serve program so please review the information and get your application in as soon as possible
- your application in as soon as possible.

  Eligible businesses include: accommodation and food service, retail, and arts, entertainment and recreation.
- Applicants may receive up to \$20,000.
- The application portal will go live Wednesday, December 2 at 9:30 AM.
  Gross sales must be between \$24,000 and \$12 million annually to be eligible.
- The program will continue until all funds have been exhausted. Any funds received
  must be deposited in the bank by the recipient on or before December 28.
