## Employers and schools have been denying medical exemptions by saying that the

only medical exemptions they will accept are those in accordance with what the CDC states is a medical exemption to a covid vaccine. The CDC says that the only people who should be medically exempt from a covid vaccine are those who have had: Severe allergic reaction (e.g., anaphylaxis) after a previous dose or to a

component of the COVID-19 vaccine within 4 hours following administration

- Immediate allergic reaction of any severity to a previous dose or known (diagnosed) allergy to a component of the vaccine within 4 hours following

religious belief to be protected by law:

the belief must be religious in nature

and it must be sincerely held.

### Religious exemptions are legally backed by the US Constitution's First Amendment

**US Constitution** 

Prohibition against discrimination or segregation in places of public accommodation, which states "All persons shall be entitled to the full and equal enjoyment of the goods, services, facilities, privileges, advantages, and

accommodations of any place of public accommodation, as defined in this

First Amendment of the United States Constitution and 42 U.S. Code § 2000a -

section, without discrimination or segregation on the ground of race, color, religion, or national origin." Failure to uphold 42 U.S. Code § 2000a may be met with legal action. **US EEOC** Religious exemptions are legally backed by the US

Equal Employment Opportunity Commission.

### employment discrimination, employers MUST offer religious and disability accommodations to vaccine requirements.
