Membership – Debbie reminded board members to encourage members to pay their annual membership. Bob and will organize membership invoices to be emailed to all members.

AGM

The agenda with timing parameters has been sent to all board members and states who will be speaking and when considering time restraints.

Diane is the MC and Georgia will manage the speaker and the reports.

Zoom will open at 11:30 - 2:30 and the meeting will start at 11:45 with a Welcome to the 6^{th} AGM by Dianne and she will include the territorial acknowledgement.

There will be one slide during the opening with a list of the board members and a power point presentation with the GBCRA history. Dr. Fearon will receive this before the meeting so he has some background of GBCRA

The Board needs to discuss succession of board members at an upcoming board meeting. Since a slate of officers can be for 2 years the slate of officers will need to be voted upon at the 2022 AGM.

Jo will discuss the process of writing and publishing her book including clips from the book, but not actually the book as she will discuss her book at the April book club meeting. Her presentation will be approximately 30-40 minutes. We will certainly plug her book and perhaps members will attend the book club that month.
