ABHP Minority Health Conference and Annual Meeting



Jasper W. Watkins III is the new Bureau Chief for Statewide Pharmaceutical Services with the Florida Department of Health. A native of Jacksonville Florida, Jasper (Jay) Watkins manages a budget in excess of \$200 million and the provision of pharmaceutical services to all Florida Department of Health facilities. He oversees the States' Pharmacy and Therapeutics Committee, Florida Formulary system, assists in expansion of the States' Pharmaceutical Stockpile Program, provides technical support for all areas of Pharmaceutical Services related to preparedness, and coordinates with the pharmacy managers of County Health Departments and DOH during times of disaster. Additionally, he is a member of Emergency Support Function #8 (Medical) and the bureaus liaison to Legislature and other outside persons regarding statewide pharmaceutical issues.

Jay received his pharmacy degree from Florida A & M University College of Pharmacy

and has a Masters in Health Services Administration from Central Michigan University. Diabetes is a Major Concern in Uganda

Health Officials in Uganda are concerned about the increasing prevalence of diabetes in Uganda. In 1972, only 254 people in Uganda were diagnosed with diabetes. Uganda currently has about 560,000 registered patients with diabetes and an estimated 560,000 undiagnosed patients. The increasing prevalence of this disease can be attributed to the adoption of the western lifestyles by many Ugandans. Ugandans are less physically active (e.g., driving more instead of walking) and consuming more processed foods.

Uganda is a landlocked, East African country bordering the Democratic Republic of Congo, Rwanda, Kenya, Sudan, and Tanzania. Much of its southern border lies along Lake Victoria. Health services and record keeping deteriorated during the 1970s and early 1980s, when many deaths resulted from government neglect, violence, and civil war. In 2000, the Ministry of Health produced a five year Health Sector Strategic Plan. The underlying theme was to increase access to a minimum essential package of health services.2 Although final data has not yet been made available, most people in Uganda still struggle to gain access to healthcare. Only 49% of the population live within 5 km of a health facility and in 2005 the per-capita income was about US\$300.3 Although 7.6% of the gross domestic product is spent on healthcare, many providers are fee-for-service, and most people cannot afford needed healthcare.4

Medications and medical supplies are available only for patients who are critically ill or able to afford them. Poor access to diabetes care has made a diagnosis of diabetes more devastating than a diagnosis of HIV. Patients with HIV have better access to health care and self care education. Patients with diabetes, especially those living in rural areas, often have no support system or education on how to manage their disease. As a result, patients with a diagnosis of diabetes have a poorer quality of life compared to a patient with HIV. Although Uganda has made great strides in the treatment and management of HIV, the groundwork still needs to be put in place for diabetes care.

Mulago Hospital, the largest hospital in Uganda, has no written diabetes education materials for their patients. Most medical information is disseminated to patients and

their families using hanging informational posters in the clinics and hospitals. However, there are currently no educational posters about diabetes. Ugandans do not have access to endocrinologists or certified diabetes educators. Few health care providers in Uganda have extensive knowledge about diabetes treatment and management.

In 2002, there were only about 270 qualified dispensers or pharmacy technicians and 171 registered pharmacists in Uganda. The current educational system in Uganda graduate only ten new pharmacists each year. Pharmacists in Uganda serve in an administrative role as pharmacy manager and have little interaction with patients. With such an enormous shortage of pharmacists in Uganda, there is little time for clinical work or counseling patients. In many pharmacies, there is no pharmacist on site and medications are dispensed with little or no instruction given to the patient.

The Uganda government needs our help. Pharmacists in the United States who are willing to volunteer their time to assist this country can help by creating educational materials for providers and patients. Simple measures such as designing prescribing protocols, creating warning labels for prescriptions, and establishing useful medication information services would help to not only advance pharmacy, but also to promote the safe and effective use of medications throughout the country. By sharing our knowledge we can help improve patient care in this impoverished country.
