

Organized Recreational Combat Simulation Roleplaying Club Waiver

I, _____, hereby agree that as a member of Organized Recreational Combat Simulation War gaming Club (henceforth known as ORCS) will pay the amount of \$5.00 for a lifetime membership. A copy of the Rulebook is available online. With each Event I attend, I will pay the amount of \$3.00. This Event fee will allow me to participate in that day's Event and act as 1 credit toward my rank in my chosen persona. Once I have attended five Events, I will receive a rank in that chosen persona. Ranks govern what abilities a particular class can use. (For more details about the rank system please see the character section of the Rulebook.)

I also understand that ORCS is a full contact sport and as such am aware of the risks, both known and unknown, that can arise. These injuries include but are not limited to permanent paralysis, broken bones and even death. I HEREBY RELEASE, DISCHARGE, AND COVENANT NOT TO SUE ORCS, its governing body, its Noble Council, its senate, Event elders and any member for responsibility for any injury I sustain during any ORCS held Event (normal Events, campouts, fairs, etc.). I release ORCS, its governing body, the Noble Council, the Event elders from all liability for injury, death, property loss and damages that result from participation in ORCS Events, in any way related to the use of the equipment, or so related to any other activity at the Event area, including all liability that results from the NEGLIGENCE of providers or any other person. I knowingly and freely assume all risk.

I also agree to comply with the rules set forth by the Rulebook, those of the Noble Council, the Senate, Event elders and that of the governing body. I understand that any violations can lead to punishment such as being timed out from the Event to expulsion from the club. A copy of the Rulebook is available online or can be presented for review when asked. I willingly agree to comply with the terms and conditions for participation. If, however, I observe any unusual significant hazard, such as un-sportsman like conduct, rule breaking and general disregard for the safety of others, during my presence or participation I will remove myself from participation and bring such to the attention of the nearest official immediately. These officials include a member of the governing body, noble council, or Event elder.

I understand that this is a roleplaying game and in order to maintain the aesthetic appearance of the game I will have an appropriate costume that conforms to the ORCS standards as outlined in the Rulebook by my 5thth Event. This costume must be appropriate for a medieval or fantasy setting. You must also be able to compete in combat with this costume.
